**Farming Industry**

This Assembly, concerned at the crisis in the farming industry, calls on the Ministry of Agriculture Fisheries and Food to introduce and fund a Cull Ewe Scheme and to reintroduce and fund the Calf Processing Scheme, and in the absence of a UK wide Calf Processing Scheme the Assembly resolves to introduce a Wales only scheme to operate from 1 October to 31 December 1999.
