BC80-04

4.1 The Chair said that the Cover Sheet accompanying BC80-04 said that the Regulations changed "*the period within which an inspection report must be completed to 35 working days in every case.*" However, this was not clear in the Explanatory Memorandum accompanying the draft Order.

4.2 The Chair said that the Explanatory Memorandum said that the draft Order had been notified to the Subject Committee in the "*reports presented by the Minister*". Members of the Committee asked if it could be suggested to the Panel of Chairs that the list of forthcoming legislation could be included on the agenda as a separate item in future.

BC83-04 & BC84-04

4.3 The Chair said that a Welsh version of this draft Order had not been submitted to the Committee. The Deputy Presiding Officer said that the draft Order was due to be considered by the Legislation Committee on 24th February. He said that the Welsh version would not be provided to the Legislation Committee's legal adviser in sufficient time and asked if the draft Order could be submitted to the Legislation Committee on 2nd March.

The Business Committee agreed the recommended procedure for BC78-

04 - BC84-04. The Deputy Presiding Officer subsequently determined that none of these draft Orders need be referred to subject committee.

4.4 The Committee noted the e-mail from Cabinet Secretariat on the use of the Executive procedure for The Vehicular Access Across Common and Other Land (Wales) Regulations 2004. The Deputy Presiding Officer asked if such e-mails could include a standard form of words and could refer to the 40-day period during which Members could table a revocation motion.

(d) Papers for Information

4.5 The Business Committee considered the paper on the translation of subordinate legislation. Members of the Committee noted that there had been a significant increase in the demands for translation services. The Deputy Presiding Officer said that he would ask the House Committee and the Government to bring forward proposals for taking forward this issue.

5.1 The Business Committee noted the letter from the Chair of the Environment, Planning and Countryside Committee identifying draft subordinate legislation for future scrutiny.

6. Forthcoming Business

BC93-04

6.1 The Committee considered a paper containing the following responses from the Business Minister to requests for various statements and debates.

- The Business Minister said that there was no intention to schedule a debate on financial and operational difficulties relating to Objective 1 funding. She said that there would be an opportunity to debate the issue in Plaid Cymru's minority party debate later that day.
- The Business Minister said that there was no intention to schedule a debate on the National Botanic Garden of Wales whilst negotiations with outside parties relating to the Garden were ongoing. Once the outcome was known, the Minister would consider whether a debate was appropriate. If a debate was not appropriate, the Minister would make a statement in Plenary.
- The Business Minister said that the Minister for Health and Social Services had given a commitment to the Health and Social Services Committee that she would make a statement on child protection issues at the same time

as the Minister for Children in England made her announcement in the House of Commons. The Business Minister said that the statement would have to deal with legal as well as policy matters and both sets of issues would have to be resolved before a statement could be made.

(ii) This Week's Business

6.2 The Committee considered paper BC87-04, which detailed the Assembly's agreed business for the week.

6.3 The Business Minister said that the Minister for Environment, Planning and Countryside would be making a statement on CAP reforms on Wednesday. She said that the motion to approve The Health Professions Wales (Transfer of Staff, Property, Rights and Liabilities) Order 2004 and The Health Professions Wales (Establishment, Membership, Constitution and Functions) Order 2004, which had been scheduled for Wednesday, would now take place on Tuesday 24th February.

6.4 Jonathan Morgan asked if a statement could be made on fire safety in care homes. Jocelyn Davies supported this request. Jonathan Morgan requested a debate on the independence of the BBC.

6.5 Jocelyn Davies asked if statements could be made on NHS waiting lists and on the financing of patients from Wales being treated in England.

6.6 Kirsty Williams asked if debates could be scheduled on the National Botanic Garden of Wales and EU Funding.
