1. Apologies & announcements

1.1 Apologies for absence were received from Alun Jenkins. The Chair welcomed Peter McAllen who was deputising for him.

BC411-03

4.1 The Chair said that this draft Order had not been published on the intranet within the target of 10 working days prior to the Committee meeting. She said that the Regulatory Appraisal which accompanied this draft Order had been prepared by the Food Standards Agency and was not specific to Wales. Members of the Committee said that a Regulatory Appraisal which was specific to Wales should have been prepared in this case. The Deputy Presiding Officer said the Business Committee could be satisfied that, if there was a judicial review, it had advised the Government correctly that a Regulatory Appraisal was required. It was agreed that the Order should be

resubmitted at the next meeting.

BC412-03 & BC413-03

4.2 Members of the Business Committee asked if Regulatory Appraisals could be prepared for these draft Orders. The Business Minister said that Regulatory Appraisals would be prepared and that the draft Orders would be resubmitted to the Committee at its next meeting. Business Managers recommended that the draft Orders should follow the standard procedure in both cases.

4.3 The Chair said that a letter from the Chair of the Local Government and Public Services Committee (BC419-03) which appeared later on the agenda, referred to this draft Order. She said that the subject committee had indicated that it would like to discuss further the draft Order, but did not want to delay its progress.

4.4 The Chair said that this draft Order would have different financial implications in different areas in Wales and said that the way in which the Explanatory Memorandum had been written understated a complex situation. The Chair asked for more clarity in the supporting papers in future.

4.5 Members of the Business Committee noted that a debate had taken place on the first Commencement Order relating to the Health (Wales) Act 2003. Members of the Committee said that the issues had been discussed and that they were content for the draft Order to follow the Accelerated procedure. Members of the Committee asked if, in future, a brief paragraph could be included in the Explanatory Memorandums explaining the reason for the Minister's recommended procedure.

4.6 Members of the Committee noted that the Explanatory Memorandum accompanying this draft Order said that no Regulatory Appraisal was required for this draft Order because the "*Assembly has no discretion in this matter*". Members of the Committee said that this was incorrect and asked for a Regulatory Appraisal. Marion Stapleton said that a Regulatory Appraisal would be prepared and that the draft Order would be resubmitted to the Committee at its next meeting.

The Business Committee agreed the recommended procedures for BC410-03 and BC414-03 - BC416-03. The Business Committee recommended the Accelerated procedure for BC417-03. The Deputy Presiding Officer subsequently determined that none of these draft

Orders need be referred to a subject committee.
