### Responses to Requests

6.1 Jocelyn Davies asked if the Business Minister would reconsider the request for an oral statement on job losses in the Wales Screen Commission. Lisa Francis said that the Minister for Enterprise, Innovation and Networks would be presenting a report to the next EIN Committee meeting. However she understood that the jobs would be lost within a fortnight. The Business Minister said she would consider the request.

6.2 The Committee noted the Business Minister's responses to requests for items of business:

There was currently no intention to make a statement on a report that two thirds of Welsh Councils were facing deficits in Adult Social Services and over a quarter were facing deficits of over £1m, as the day to day management of budgets was a matter for local authorities.
