**1. Apologies & announcements**

1.1 Apologies for absence were received from Kirsty Williams. The Chair welcomed Peter Black who was representing her in accordance with Standing Order 13.3.

**2. Minutes of the previous meetings****(i) BC(2)33-05 (Final minutes) - Tuesday 6<sup>th</sup> December 2005**

**3. Matters Arising****Draft Minutes of meeting of 10 January 2006**

3.1 **Paragraph 4.4** Marion Stapleton reported that the Royal Institute of Chartered Surveyors (RICS) did not intend to issue the *Rent Only Residential*

*Management Code* in Welsh and that there was no statutory obligation for them to do so. She said that the Government were encouraging some organisations who were not required to have a Welsh Language Scheme to issue documents bilingually and she would report back on whether or not the RICS was one of those organisations. It was agreed that the Chair should write to the RICS encouraging them to issue the Code in Welsh, and also to the Welsh Language Board.

**3.2 Paragraph 4.5** Marion Stapleton circulated a paper which set out the background to the Cabinet's decision to delegate authority to the Minister for Environment, Planning and Countryside to use the Executive procedure for emergency legislation to control exotic animal diseases. Members of the Committee agreed that these arrangements were appropriate in the circumstances. In response to a question Alun Jenkins confirmed that DLS believed that these arrangements complied within Standing Order 24.27.

**3.3 Paragraph 4.8** The Chair reported that the Foot and Mouth Disease (Control of Vaccination) (Wales) Regulations 2006, which had been amended since its scrutiny by the Environment, Planning and Countryside Committee, were being re-submitted to the Committee.
