1. Apologies & announcements

BC440-03

4.1 The Chair said that this draft Order had been considered by the Committee in its previous meeting but had been deferred. She said that the draft Order had now been available on the Intranet for the target of 10 working days prior to the Committee meeting but that a Regulatory Appraisal, which was specific to Wales, had not been prepared. Members of the Committee reiterated their view that a Regulatory Appraisal which was specific to Wales should have been prepared in this case and that the Business Committee could be satisfied that, if there was a judicial review, it had advised the Government correctly on this issue.

4.2 The Chair said that this draft Order had been considered by the Committee in its previous meeting but had been deferred because the Committee had asked if a Regulatory Appraisal could be prepared. Members of the Committee referred to Paragraph 3 of the Regulatory Appraisal, which said that "*This Order is not discretionary*". Members of the Committee said that although the Assembly was required to make the Order, the content of

the Order was discretionary. It was agreed that this sentence would be removed from the Regulatory Appraisal.

BC442-03 & BC443-03

4.3 The Chair said that these draft Orders had been considered by the Committee in its previous meeting but had been deferred because the Committee had asked if Regulatory Appraisals could be prepared. Members of the Committee said that the references to costs in the Regulatory Appraisal were not detailed enough and said that the Regulatory Appraisal was not comprehensive. It was agreed that Marion Stapleton would report back on the costs arising from making the Order at the Committee's next meeting.

4.4 The Chair said that the Explanatory Memorandum accompanying this draft Order contained an explanation for the Minister's recommended procedure. The Business Committee welcomed this. Jocelyn Davies said that paragraphs 1.2 and 2.2 of the Regulatory Appraisal were contradictory and asked for further clarification. The Business Committee agreed that the draft Order should be resubmitted to the Committee at its next meeting.

4.5 Members of the Committee noted that the Regulatory Appraisal accompanying this draft Order was not comprehensive in its references to the costs arising from making the draft Order. However, more detailed information was included in the Explanatory Memorandum accompanying the draft Order. Members of the Committee asked if all relevant information could be included in the Regulatory Appraisal.

The Business Committee agreed the recommended procedures for BC440-03 - BC443-03 and BC446-03. . The Business Committee recommended the Accelerated procedure for BC445-03. The Deputy Presiding Officer subsequently determined that none of these draft Orders need be referred to a subject committee.
