**1. Apologies & announcements**

1.1 Apologies for absence were received from Kirsty Williams. The Chair welcomed Peter Black who was representing her in accordance with Standing Order 13.3.

3.1 **Paragraph 3.1** Marion Stapleton confirmed that the Royal Institute of Chartered Surveyors (RICS) did not intend to issue the *Rent Only Residential*

*Management Code* in Welsh and that there was no statutory obligation for them to do so. She said that the RICS was not currently one of the organisations without a Welsh Language Scheme which the Government was encouraging to issue documents bilingually. The Chair said that she would now write to the RICS encouraging them to issue the Code in Welsh, and also to the Welsh Language Board.

4.1 Members noted that the General Practitioners Committee (Wales) had been consulted about this draft Order but that there was no information about their response. Marion Stapleton said she would report back on this issue.

4.2 Peter Jones said that it was not clear from the supporting papers for this Order whether the amendments proposed as a result of consultation had been incorporated in the draft Order. He pointed to a proposed amendment to refer to town councils in Article 6 which did not appear to have been taken on board. Marion Stapleton said that she would confirm the position at the next meeting; and provide Members with details of how each proposed amendment had been incorporated into the draft Order in good time for the Plenary debate.

4.4 Members noted the email about the proposal to confirm a CPO. In response to a query Alun Jenkins said that the local authority would have had to have regard to their Welsh Language Scheme in preparing the Order.

5.1 The Committee considered a paper on the implications of Clause 29 of the Government of Wales Bill for Committees after May 2007. Following extensive discussion the Chair said that this had been a valuable opportunity for members to consider the future shape of committees and the Standing Order changes which might be necessary. She urged those groups who had not yet done so to take advantage of the presentations being offered by MRCS.

5.2 The Committee considered a paper on the scrutiny of the Children's Commissioner's Annual Report. It was agreed that a joint meeting of the ELL, HSS, SJR and EOC Committees should be held before the end of February at a time to be agreed amongst the Chairs when clashes could be kept to a minimum.

5.3 The Committee considered a paper on the Committee on Rail Infrastructure and Improved Passenger Services. The proposed meeting arrangements and the proposed Standing Order amendment to allow substitutions were agreed. A draft report of the Business Committee would be submitted to the next meeting.

## **6. Forthcoming Business**

6.1 The Business Minister responded to requests from Business Managers and said that:-

- The Minister for the Environment, Planning and Countryside had issued a written statement on the north Wales water supply

- There was no intention to make time available for a separate debate on European funding as this could be covered in the debate on matters relating to the European Union, which was scheduled to take place on Wednesday 25 January.
- A debate on palliative care would be scheduled later in the session.
