#### BC(2)32-06(p12)

6.1 The Committee noted the Business Minister's responses to requests for items of business:

There was still no intention to make a statement on arrangements with Westminster for Orders in Council post May 2007, as the procedures were laid out in the Government of Wales Act 2006, and were currently being considered the Standing Orders Committee.

There was currently no intention to schedule a debate on the Convergence Programme, as Members had been consulted on the draft programme.

A written statement had been issued on the bird flu vaccine.

There was currently no intention to make a statement on any discussions between Ministers and Westminster regarding intentions to reduce consumer debt in Wales. The Minister for Social Justice and Regeneration had reported to the SJR Committee on 19<sup>th</sup> October on the review of Over-Indebtedness.

There was currently no intention to make a statement on the security of Welsh Ferry Ports against terrorist attacks, as this was a non-devolved matter.

There was currently no intention to make a statement on Road Congestion charging.

There was currently no intention to make a statement on the safety of the first Severn Bridge, as a written statement had been issued on 6<sup>th</sup> October and further evaluation was underway.

There was currently no intention to make a statement on the relocation of the Wales Screen Commission. Members had an opportunity to raise the issue during questions to the Minister for Enterprise, Innovation and Networks' on 15<sup>th</sup> November and there had been an opportunity for Committee Members to raise the issue during the EIN Committee meeting on 22<sup>nd</sup> November.

She said that the statement which had been scheduled for 12<sup>th</sup> December would be insufficient and it would be preferable to hold a debate to allow Members the opportunity to discuss the issue. Business Managers supported the request. The Business Minister said she would consider the request.

6.7 The Committee considered a paper on the delegation of functions under the Railways Act 2005. The Business Minister thanked the Chair for allowing the late circulation of this paper. However she said it was necessary for the Committee to decide whether the delegation of functions should be transferred to the First Minister or to the Enterprise, Innovation and Networks Committee. The Deputy Presiding Officer suggested that the guidance arising from the Order could be considered by the Assembly in Plenary without the need to delegate the necessary functions. Business Managers agreed with this proposal.
