**1. Apologies & announcements**

1.1 Apologies for absence were received from Kirsty Williams. The Chair welcomed Peter Black who was representing her in accordance with Standing Order 13.3.

**2. Minutes of the previous meetings**

**(i) BC(2)02-06 (Final minutes) - Tuesday 17<sup>th</sup> January 2006**

2.1 The minutes were presented to the Committee in their final format. As there were no comments, they would be translated in readiness for publication.

**3. Matters Arising**

**Draft Minutes of meeting of 24<sup>th</sup> January 2006**

3.1 **Paragraph 3.1** The Chair said that a letter to the RICS encouraging them to issue the *Rent Only Residential Management Code* in Welsh had been prepared .

3.2 **Paragraph 4.1** Marion Stapleton said that the General Practitioners Committee (Wales) had not responded to the consultation on the *General Medical Services Transitional and Consequential Provisions (Wales) (Amendment) Order 2006* and that the Regulatory Appraisal had been amended accordingly.

3.3 **Paragraph 4.2** Marion Stapleton confirmed that the amendments proposed as a result of consultation had been incorporated in the draft *Local Government (Improvement Plans) (Wales) Order 2006* with the exception of amendment 6 which was unnecessary. She said that the Minister would be writing to the Local Government and Public Services Committee with details of how each proposed amendment had been incorporated into the draft Order and that the supporting papers would be revised before the Plenary debate.

3.4 **Paragraph 4.3** Marion Stapleton said that the supporting papers for the *Housing Revenue Account Subsidy (Wales) Determination 2006-2007*; and the *(Wales) General Determination of the Item 8 Credit and Item 8 Debit 2006-2007*, had been revised to make it clear which the procedures under Standing Order 29.3 were being applied and the reasons for the Minister's decision.

5.1 **Paragraph 5.2** Peter Black said that it was likely that the joint Committee meeting on the Annual Report of the Children's Commissioner would take place on 13<sup>th</sup> March and asked the Business Minister to encourage all of the relevant Ministers to attend

**The Business Committee recommended the Standard procedure for BC(2)02-06(p1); BC(2)02-06(p3); BC(2)03-06(p4); BC(2)03-06(p5) and BC(2)04-06(p7); and the Accelerated procedure for BC(2)02-06(p2). The Deputy Presiding Officer subsequently determined that none of these draft Orders need be referred to a Subject Committee.**

**BC(2)03-06(p4) - BC(2)04-06(p7)**

4.1 Marion Stapleton said that these draft orders were the first of a number of pieces of legislation on dentistry.

4.2 In response to a query, Marion Stapleton confirmed that the Minister had decided that it was not reasonably practicable for the draft Order to be prepared in Welsh in accordance with Standing Order 24.2. It was noted that the reason provided was that there had not been sufficient time. Alun Jenkins said that the Minister's decision had been informed by the nature of the consultation process on the draft Orders and not the availability of resources.

**BC(2)03-06(p6)**

4.3 The Chair referred to the Committee report on this draft Order which said that an amendment had been agreed. However, paragraph 18 of the Explanatory Memorandum said that the Minister had decided not to include the amendment in the regulations and had written a letter of explanation to the Chair of the Health and Social Services Committee. Marion Stapleton said that the letter should also have been sent to the Chair of the Business Committee. It was agreed to postpone consideration of the draft Order until the next meeting when the letter could be included amongst the supporting papers.

**(b) Standing Order 29 Subordinate Legislation**

4.4 The Chair said that the supporting papers for this draft legislation did not make it clear which of the procedures under Standing Order 29.3 were being applied and the reasons for the Minister's decision. The Deputy Presiding Officer asked if this could be included in the template for Cover Sheets accompanying such legislation.

#### **BC(2)04-06(p10)**

6.1 The Business Minister responded to requests from Business Managers and said that:-

- The Minister for Education and Lifelong Learning would be issuing a written statement on vocational training for ex-offenders at the earliest opportunity
- Although the Post Office is a non-devolved matter, the Minister for Social Justice & Regeneration would look into the implications for Wales of the UKr Government's proposal to abolish the Post Office Credit Account. The Minister would report back to the Subject Committee in due course.
- The Minister for Social Justice & Regeneration was aware of concerns surrounding the *Supporting People* Grant and would be reporting back to the Subject Committee upon this in due course.
- NICE intended conducting a consultation exercise on its proposals on specialist drugs in relation to Alzheimer's and the Welsh Assembly Government did not intend commenting on them until the consultation had concluded and the outcome was published.
- The Welsh Assembly Government would make a statement in due course on progress towards free home care for the disabled. The Business Minister would notify the Business Committee about timing.
- The Minister for Health and Social Services did not intend making specific time available for a statement on the food as Cefn Coed Hospital, Swansea. There had been an opportunity to raise the matter during Questions to the Health Minister on 25 January.
- The Minister for Economic Development and Transport would issue a written statement on the role of the Welsh Assembly Government in the UK Government's review of energy by 3rd February.

- The Minister for Economic Development and Transport would issue a written statement on the safety of the NLG terminal at Milford Haven by 3rd February.
