1. Apologies & announcements

3.1 Paragraph 9.2 The Chair referred to the motion to suspend Standing Orders to bring forward a motion to revise Standing Orders, which had been withdrawn during Plenary on Tuesday 7th February. The Chair said that she had not been consulted before the motion to suspend Standing Orders was withdrawn. Members of the Committee said that it would be preferable if, in future, motions to revise Standing Orders were subject to the full notice period as outlined in Standing Orders. The Deputy Presiding Officer asked the Clerk to look at the procedures in relation to this issue and report back to the Committee in due course.

The Deputy Presiding Officer subsequently determined that none of these draft Orders need be referred to a Subject Committee.

4.1 The Chair noted that these Regulations had been notified to the Health and Social Services Committee. She said that it had been agreed by the Committee that legislation which was also relevant to the Environment, Planning and Countryside (EPC) Committee should also be notified to that Committee. Marion Stapleton said that this was usually the case. The Committee agreed to notify the EPC Committee.

4.2 The Committee noted that it had been determined that these draft Orders, which related to dental services, would not be made bilingually. Members of the Committee reiterated their concern that the Orders would not be available in Welsh.

6.1 The Business Minister responded to requests from Business Managers and said that:-

- There was no intention of scheduling a statement on the Business Incentives Grant, but the Minister for Local Government and Public Services would notify the Local Government and Public Services Committee of the interim distribution of Local Authorities Business Growth Incentives Scheme in its next meeting.
- The Minister for Health and Social Services would be making a statement on progress towards free home care for the disabled on 15 February.
- A debate on NHS Trust Finances would be scheduled once the financial outturn figures were known at the end of this financial year.

6.2 The Committee considered this paper, which detailed the Assembly's agreed business for the week.

6.3 The Business Minister said that the statement on British Sign Language (BSL), which had been scheduled for Tuesday, had had to be postponed because of the practicalities of providing BSL interpretation in the new Chamber. The Committee agreed to refer the issue of the provision of facilities for BSL interpretation to the House Committee for urgent consideration at its meeting on 9 February.

6.4 The Business Minister said that the indicative timings for Wednesday's meeting showed that the meeting would overrun. She suggested that, if Business Managers wished, the debate on the use of B&Bs for homeless families, which had been scheduled for Wednesday 8th February, could be moved forward to Tuesday 7th February. Business Managers said they felt that it would be preferable for the debate to take place on Wednesday, and suggested that the meeting could be extended if there was a lack of time.
