**The Business Committee recommended the Standard procedure for BC(2)08-06(p1); BC(2)08-06(p2) and BC(2)08-06(p5). The Committee recommended the Accelerated procedure for BC(2)08-06(p3), BC(2)08-06(p4) and BC(2)08-06(p6). (Following the meeting, the Deputy Presiding Officer determined that none of these draft Orders need be referred to a Subject Committee.)**

4.1 The Deputy Presiding Officer referred to the Explanatory Memorandum accompanying this draft Order, which said that this draft Order was “*designed to facilitate the introduction and operation of the new capital finance system, ‘the prudential system’, as set out in Part 1 of the 2003 Act.*” He asked if the Explanatory Memorandum could include an explanation of the prudential system.

##### **BC(2)08-06(p5)**

4.2 The Chair referred to the draft Report of the Health and Social Services Committee on this draft Order. She said that the Report did not contain sufficient detail to inform discussions properly. Karin Phillips said she would look at Committee reports generally and at ways of improving the information provided in them. The Chair referred to the paragraph on financial implications in the Explanatory Memorandum accompanying this draft Order, which gave a global figure for the ASPB merger programme. The Committee asked if more detailed figures could be provided on the financial implications of this particular draft Order. The Business Minister said that this information would be provided.

**5. Committees**

**BC(2)08-06(p10)**

5.1 The Committee noted the paper from the Members' Research Service on the parliamentary progress of Bills of relevance to the Assembly. The Chair referred to the covering note, which said that the Minister for Health and Social Services had indicated to the Health and Social Services Committee that "*the Assembly Government will only press for framework powers if they are necessary to deliver WAG policy objectives*" and "*framework powers are unlikely to be included (in Bills) unless the Assembly Government demonstrates that they will be used with 'some immediacy'*." The Business Minister said she would report back to clarify the position.

**6. Forthcoming Business**

**BC(2)08-06(p11)**

6.1 The Business Minister responded to requests from Business Managers and said that:-

- A debate on Public Sector staff safety (particularly A&E staff) would be scheduled later in the term.
- A statement by the Minister for Local Government and Public Services on Council Tax rises would be scheduled when Local Authorities had completed the process of setting the council tax rates for next year.

- A written statement on passenger safety on trains and on railway stations had been issued.
- There was no intention of scheduling time for a statement on funding the police mergers or a statement on the possible loss of 60 police jobs in North Wales as these were non-devolved matters.
- The Business Minister would make a statement on the UK Gender Pay gap on 14<sup>th</sup> March.
- The Minister for Health and Social Services would be making a statement on the new contract for the supply of oxygen soon.
- There was no intention of making a statement on Continuing Care as the matter could be raised during the Minister for Health and Social Services' question time.
- There was no intention of scheduling a statement on the Malcolm Wicks announcement that there would be an 18% increase in energy production by 2010.
- A written statement on Avian Flu would be issued later this week and the Minister for Environment, Planning and Countryside would provide oral updates as developments unfolded.
- The Minister for Environment, Planning and Countryside would issue a written statement on Foot and Mouth contingency plans.
- There was no intention of scheduling a statement on diabetes in relation to Chiropody Services as Local Health Boards and Trusts would be expected to manage the clinical needs of their local population in relation to general chiropody services. However, the situation would be kept under review by health officials.
- The Minister for Economic Development and Transport would issue a written statement on the Kwik Save/ Sommerfield sale of 68 Welsh stores shortly.

6.2 Peter Black asked when the statement on the new contract for the supply of oxygen would be scheduled. The Business Minister said that the statement would be scheduled to take place in the next three weeks.

### This Week's Business

#### **BC(2)08-06(p12)**

6.3 The Committee considered this paper, which detailed the Assembly's agreed business for the week.

6.4 The Business Minister said that it had been proposed to suspend Standing Orders later that day to debate a motion to thank the Parliament of New South Wales for the gift of a mace. The Committee believed it would be appropriate for the debate to be held, with notice, on Commonwealth Day (15<sup>th</sup> March)

rather than by suspending Standing Orders today.

6.8 Peter Black asked if the following items of business could be scheduled:

- A statement on the lecturers' pay dispute and a debate on the funding of the Higher Education sector as a whole
- A statement on the progress for change agenda
- An oral statement on the supply of oxygen contract.
- A statement on the Assembly's commitment to fair trade.

6.9 The Committee noted the Business Minister's proposed statement about the organisation of the Assembly's business for the weeks commencing 14<sup>th</sup> March, 21<sup>st</sup> March and 28<sup>th</sup> March.

6.10 Karin Phillips referred to the election of a Planning Decision Committee, which had taken place on 28<sup>th</sup> February. She said that there had been a problem with the Committee, as one of the members had realised that he would be obliged to declare an interest in the subject matter. She said that the Committee would need to be replaced by a new one and that this would be arranged shortly.
