Item 1: Introductions, apologies, substitutions and declarations of interest.

Item 2: Collections Management at the National Museums and Galleries of Wales

- 2.1 The Committee took evidence from Michael Houlihan, Director General, National Museums and Galleries of Wales and Eurwyn William, Deputy Director General, National Museums and Galleries of Wales.
- 2.2 A verbatim transcript will be attached as Annex 1 to these minutes.

Item 3: Welsh Assembly Government's response to the Audit Committee report on 'Compensating Farmers for Bovine Tuberculosis in Wales'

- 3.1 The Auditor General said that the Welsh Assembly Government had responded positively to the Committee report and had accepted all 8 of its recommendations. In view of the current work being undertaken to eradicate the backlog of overdue tests for Bovine Tuberculosis, the Auditor General agreed to provide a report to the Committee on the progress made by the Assembly Government in implementing the recommendations in six months.
- 3.2 The Committee agreed to accept the Welsh Assembly Government response to its report.

Action point

Auditor General to provide a progress report to the Committee on the implementation of its recommendations in six months.

Item 4: Welsh Assembly Government's response to the Audit Committee report on 'The Disposal of the Mid Wales Hospital'

4.1 The Auditor General said that the Welsh Assembly Government had accepted all 11 of the Committee's recommendations. He said that he would keep under review the progress made by the

Assembly Government on the implementations of the recommendations.

4.2 The Committee agreed to accept the Welsh Assembly Government response to its report.

Item 5: Set-up costs of the Wales Audit Office

- 5.1 The Auditor General explained the background to the draft Public Audit (Wales) Bill and the proposed Wales Audit Office. At the 23 October 2003 Audit Committee Members considered a memorandum on the costs that were likely to be incurred in setting up the Wales Audit Office. The latest estimate of these costs based on work undertaken and provisional quotes was £987,000.
- 5.2. Ian Summers said that the total forecast cost of £350,000 for information and communications technology would cover the purchase and installation of new IT infrastructure, networking and telecommunications for the new organisation as well as specialist support which would be required.
- 5.3 The contract for the configuration of the new information and communications technology had not yet gone out to tender. It was envisaged that the contract would include an appropriate penalty clause.
- 5.4 Members accepted the explanation given for the increase in the estimate, whilst noting that it represented a doubling of the original estimate produced by the Government.
- 5.5 The Committee approved the estimate of the set-up costs of the Wales Audit Office.

Item 6: Paper to note - Correspondence from the Permanent Secretary on recommendations contained in the Audit Committee report 'OSIRIS'
