Item 6: Welsh Assembly Government oversight into Assembly Sponsored Public Bodies and their financial management

- 6.1 The Committee took evidence from Sir John Shortridge, Permanent Secretary, National Assembly for Wales and David Richards, Principal Finance Officer, National Assembly for Wales in connection with the report by the National Audit Office on behalf of the Auditor General for Wales on 'ELWa- The National Council for Education and Training for Wales: Financial Management of Partnership and Innovation and Development Projects'.
