Item 2: Compensating Farmers for Bovine Tuberculosis in Wales

- 2.1 The Committee took evidence from Sir Jon Shortridge, Permanent Secretary, National Assembly for Wales, David Richards, Principal Finance Officer, National Assembly for Wales, Tony Edwards, Chief Veterinary Officer for Wales and Colin Williams, Head of Animal Health Division, National Assembly for Wales in connection with the report by the National Audit Office on behalf of the Auditor General for Wales on 'Compensating Farmers for Bovine Tuberculosis in Wales'.

Item 3: Programme of Value for Money examinations and Estimate of the Income and Expenses of the Auditor General for Wales

- 3.1 The Auditor General for Wales introduced a paper outlining the proposed value for money examinations for the financial year 2004-2005. The programme also included details of work planned or underway for the financial year 2003-2004 and provided details of proposed value for money examinations for 2005-2006 and beyond.
- 3.2 He outlined the estimate of the income and expenses for the year ending 31 March 2005 and explained the request for the proposed increase of £205,000 on the 2003-04 estimate.
- 3.3 The Committee noted the supplementary Memorandum on the set up costs of the Wales Audit Office.
- 3.4 The Committee supported the planned programme and financial estimate. Members requested that the AGW give consideration to including in the programme an examination of the use of NHS resources for private consultancy work. The AGW agreed to take account of Members' views and would return to the Committee in due course with his final programme of work for 2004-05.
