Insert new bullet point after bullet point b and re-order accordingly:

Supports the recommendations of the House of Commons Welsh Affairs Committee into Social Exclusion in Wales as a means of improving levels of basic skills.

Amendment 4 - Jocelyn Davies (South East)

Insert new bullet point after bullet point b and re-order accordingly:

Notes that market-driven inequalities in statutory education are likely to exacerbate the problems of low levels of basic skills in our most disadvantaged communities.
