The Assembly resolves to instruct the Environment Minister to bring forward subordinate legislation, the effect of which will be to amend the Use Classes Order 1987 to exclude the storage of radioactive materials from Class B8 (Storage and Distribution).

The objective to be achieved is that future proposals for storage and distribution facilities would not allow storage of radioactive materials unless a planning permission specifically for such purpose is applied for and granted.

recognises that Scotland and England have set targets for the recruitment of NHS frontline staff, rather than just trainee targets as contained in *Improving Health in Wales*;

Amendment 4 - Jocelyn Davies (South Wales East)

In bullet point two delete 'Endorses the objectives for 2001-02 and subsequent years in the light of' and replace with 'notes'

Amendment 5 - Jocelyn Davies (South Wales East)

Add at end of motion:

'and to further the aims of the "Human Resources Strategy " and "Improving Health in Wales" calls for a set of national targets to be established, to reduce staff shortages, improve retention rates, and aid the recruitment of nurses, doctors and those in professions allied to medicine.'

Amendment 6 - William Graham (South Wales East)

Add at the end of the motion

sets the following targets for the number of additional full time equivalent staff in NHS Cymru by 2004; at least:

375 more hospital consultants;

100 more GPs;

1,000 more nurses, and;

325 more therapists and other health professionals
