## 2. William Graham (South Wales East):

Delete full stop after "Spending Review" and add:

and therefore calls on the Liberal Democrat/Labour Administration to set a specific Standard Spending Assessment for delegated schools budgets for each local authority in Wales, as suggested in the consultation paper *Simplifying the System*, in order to ensure a greater degree of transparency for parents and local voters in the funding of maintained schools in their area.

The National Assembly endorses recommendations regarding the funding of education in Wales as outlined by the Audit Commission on page 61 their report *Money Matters*, issued in November 2000.

The National Assembly also calls upon the Liberal Democrat/Labour Administration to set Welsh LEAs a target to raise the percentage of their local schools budget delegated to schools from the current 81% to 90% for 2002/03, and notes that the levels of delegation by English local authorities is currently at 84%.
