Minority Party Debate: The Conservative Party

This National Assembly notes:

- the Liberal Democrat/Labour Administration's contention in *Improving Health in Wales* that "the traditional District General Hospital has served a population of around 200,000 to 250,000 people. Effective planning of secondary care now requires us to look at a population base of 500,000 people or more" (pg.16);
- the Administration's subsequent conclusion in *Improving Health in Wales* that "we will see an overall reduction in the number of traditional hospitals" (pg.16) in Wales.

The National Assembly calls upon the Liberal Democrat/Labour Administration to:

- 1. confirm that no existing Accident & Emergency department will be closed;
- 2. reject any plans to reduce the number of DGHs so as to reflect a population catchment of 500,000 or more;
- 3. confirm that the DGH model is not being abandoned;
- 4. provide £20 million for the construction of a National Children's Hospital for Wales.

6. Reviewing the concept of the health economy model, discussed in the document Access & Excellence" so that the:

- Capacity to deliver services in Wales is developed
- The regional needs of Wales are taken into account

Delete original point 3 and replace with

'The National Assembly recognises that fossilising the current model of service provision is an unsustainable strategy that will not aid in strategic long-term planning and will not deliver an improvement in patient care.'

Add new points at the end of the motion;

- 5. Develop a NHS in Wales that has its focus firmly in the community, expanding and strengthening the all Wales network of community hospitals.
- 6. Increase the capacity of the NHS in Wales.
