#### Item 7 Debate on Communities Strategies

To enable consideration and approval of the draft guidance to local authorities on "Preparing Community Strategies"; the process of preparing and implementing the strategies which will entail close co-operation between local authorities, their partner bodies and local communities; and comment on the strategies' potential for co-ordinating and rationalising planning arrangements across the public sector in Wales.

# NDM677 To propose that the National Assembly

1. Welcomes the broad community leadership role for local government implied by Section 4 (1) of the Local Government Act 2000 which can be found on the Internet at http://www.hmso.gov.uk/acts/acts2000/20000022.htm\_and which places on county and county borough councils

in Wales a duty to prepare 'community strategies' for promoting or improving the economic, social and environmental well-being of their areas and contributing to the achievement of sustainable development in the UK.

2. Adopts the document 'Preparing Community Strategies' prepared in accordance with Section 4 of the, Act laid before the National Assembly on 24 May 2001 which:

(a) provides guidance to local authorities

(b) commits the Administration to coordinating and streamlining the variety of planning frameworks in local government

(c) confirms the role of the Administration's agencies in working in partnership with local authorities to develop community strategies.

## The following amendments have been tabled:

3. Calls on the Labour / Liberal Democrat Administration to bring forward a timetable outlining which planning frameworks they intend streamlining and the date by which this will be accomplished.

Amendment 3 - Jocelyn Davies (South Wales East);

Delete bullet point 2(c), and add new point at end of motion:

4. Calls on the Labour / Liberal Democrat Administration to instruct it's agencies to work in partnership with Local Authorities to develop community strategies.

Amendment 4 - William Graham (South Wales East);

At the end of point 2 add a new sub point that reads:

(d) "fails to address the social exclusion and distinct requirements of certain groups of people who are members of all our communities.

Amendment 5 - William Graham (South Wales East); At the end of point 2 add a new sub point that reads:

(e) "fails to fully engage Independent sector businesses to participate and invest in their community strategies.

Amendment 6 - Jocelyn Davies (South Wales East); Add as new point at end of motion:

5. Calls on all Local Authorities in Wales to work with other groups within their communities when preparing 'community strategies'.
