In accordance with the revised guidance on the Grouping, Selection and Refusal of Amendments, the Presiding Officer has determined the order in which they will be taken for the purposes of debate. Votes will be taken separately:

1. Jocelyn Davies (South Wales East)

Delete all after National Assembly for Wales and replace with:

- 1. Acknowledges the role of the Welsh Assembly Government's energy policy in mitigating the consequences of climate change; and
- 2. Notes with concern that the current lack of powers limits the scope and development of energy policy in Wales and calls on the Welsh Assembly Government to strengthen representation to UK government for the devolution of all relevant powers on this matter

2. David Melding (South Wales Central):

Add new point at end of motion:

Notes the concerns that leading business organisations have regarding the Energy Wales Route Map.

3. David Melding (South Wales Central):

Add new point at end of motion:

Notes that if implemented in its current form the energy route map will lead to a net increase in greenhouse gas emissions.

4. David Melding (South Wales Central):

Add new point at end of motion:

Regrets the absence of any reference to nuclear power despite the fact that nuclear power provides 30% of Wales' energy supply.

5. David Melding (South Wales Central):

Add new point at end of motion:

Calls on the Welsh Assembly Government to lead an informed debate on whether nuclear power generation should continue to play a part in meeting Wales' energy needs.

6. Kirsty Williams (Brecon and Radnorshire)

Add new point at end of motion:

Believes in the importance of local democracy in the achievement of the 4 TWh (terawatt hour) target.

7. Kirsty Williams (Brecon and Radnorshire)

Add new point at end of motion:

Calls on the Labour Assembly Government to improve energy security by supporting the production of local renewable energy systems other than on-shore wind.

Directs the Assembly Government to run a high profile, focused energy saving campaign in Wales.

Calls on the Welsh Assembly Government to bring forward proposals for a detailed programme of energy conservation and efficiency measures

Calls for the responsibility for energy policy presently retained by Westminster in relation to Wales to be transferred to the Assembly and in the meantime presses the UK government not to take any decisions on new nuclear power installations in Wales

Calls on the Welsh Assembly Government to provide greater support for Wales-based research and development into alternative renewable energy and energy efficiency technologies

Calls for the proposed coal planning TAN (Technical Advice Note) to take a presumption against open cast mining in principle, but where majority local opinion is in favour there should be a 500m buffer zone between the site boundary and residential settlements, schools and hospitals
