The following Statement of Purpose and Costs made in accordance with Standing Order 24.16 (ii) was tabled alongside the above amendment to the Order.

Purpose

To require that new properties classed as houses in multiple occupation (HMOs) install fire sprinklers in order to minimise loss of life, injury and damage to property as a result of fire.

Justification

In the UK each year there are around 45,000 fires in dwellings and while many of these involve damage which is little more than superficial, more than 500 people have died in fires in their home in the UK almost every year since 1945.

The introduction of smoke alarms in the late 1970s has helped to reduce some of this death toll but even the best estimates suggest that only around 30 lives are saved annually by early warning.

On examination of the statistics on fires, it becomes obvious that a disproportionate number of the very young, the very old, the disabled are the people who die as a result of fires.

One other group also features in the list of the most vulnerable and that is those who live in shared accommodation - 'homes in multiple occupation' or HMO's. One calculation suggests that someone living in an HMO is eight times more likely to die in a fire than someone living in a single family dwelling. Some local authorities are now suggesting the landlords who let rooms in HMO's which are three or more storeys in height should fit sprinklers. In Scotland, legislation introduced in 2005 now requires all new care and residential homes to be fitted with sprinkler protection and in some areas, sheltered housing is also being so protected.

Cost Implications

Costs (Including costs falling on other bodies)

Expenditure will be incurred by local housing authorities in implementing the Regulations. These costs will include initial training, running costs of the licensing scheme for HMOs, administration costs and enforcement costs. However, these costs would be incurred regardless of an amendment to include fire sprinklers, which would be likely to result in a minimal increase in cost.

Costs associated with installing a fire sprinkler system would be borne by the developer and would be minimal. These costs would be accounted for within the price of the property.

The potential costs of water damage caused by sprinklers needs to be considered. According to the South Wales Fire Safety Service, Cardiff, fire sprinkler systems are heat activated and would not be triggered by smoke. Sprinkler heads also operate independently so only the sprinkler in the area of a fire would be activated (assuming the fire does not spread). Any water damage caused by the sprinkler that activates as the result of a fire is likely to be less than the damage that would have been caused by the fire itself.

According to a financial memorandum to the Fire Sprinklers in Residential Premises (Scotland) Bill *1, the average cost of installing a fire sprinkler system into an HMO would be £1,500 *2, although this is dependent on the size of the property. This is in reasonably close agreement with the average cost stated by Walsall Council *3.

So sprinklers, unlike smoke detectors which can only warn of the need for evacuation, can actually save those who cannot help themselves.

Purpose

To increase the number and types of properties that are required to conform to Houses of Multiple Occupation licensing Regulations.

Justification

During the consultation for these regulations, Shelter Cymru, suggested that mandatory licensing should apply to all HMOs. However, local authorities will have powers in the Act to licence HMOs over and above the mandatory level of three storeys and five or more occupants. These amendments will enable local authorities to license below that level.

Cost Implications

Costs (Including costs falling on other bodies)

Expenditure will be incurred by local housing authorities in implementing the Regulations. These costs will include initial training, running costs of the licensing scheme for HMOs, administration costs and enforcement costs.

Information on the number of HMOs in Wales is not held centrally. They are collected by individual local authorities. A Welsh Assembly Government Official has provided a rough estimate of 20,000 HMOs in total in Wales.
