Team Wales is able to provide prospective investors with the seamless delivery of a range of services from initial contact, advice on the availability of property, location and workforce issues through to advising prospective investors of the availability of grant to assist with start-up costs.

For its part, the National Assembly has a range of grants, which are available to assist developments by indigenous business and overseas companies wishing to invest in Wales. With Objective 1 status for

much of Wales and with a National Assembly committed to furthering economic development, there has never been a better time to undertake investment in Wales.

The First Minister: The European Task Force for Wales, established in November 1998 by Peter Hain MP, followed a central initiative by HM Treasury and the Department for Trade and Industry to establish regional fora which would help businesses to take forward business preparations locally. The Taskforce is now supported by the Assembly and includes representatives of the business community in Wales among other members. The Taskforce's remit is to assist Welsh businesses to address the practical implications for them of the adoption of the euro in most of the European Union, with which we have extensive trading relations; it is not concerned with the question of whether the United Kingdom should adopt the euro.

Since the Task Force first met in 1998, it has been very active at providing advice on euro issues and raising awareness. This has been done through a variety of measures including conferences, exhibitions, a telephone helpline with access to an expert panel, an information web-site and leaflet distribution.

The current Chairman is Peter Graham-Woolard, Director of Manufacturing Operations UK at Rizla UK Ltd. Mr Graham-Woollard is to make a presentation about the Task Force's work at the next meeting of the Committee on European Affairs.
