# Questions to the Minister for Culture, Sport and the Welsh Language

# **Input into Westminster Legislation**

**Q7 Ieuan Wyn Jones:** How will the Minister for Culture, Media and Sport secure effective input into the forthcoming Westminster legislation on broadcasting and communications? (OAQ9047)

The Minister for Culture, Sport and the Welsh Language (Jenny Randerson): I have already been identifying issues for Wales emerging out of the British Government's communications White Paper. I tabled a paper about this, which was discussed at the Culture Committee yesterday. We have scheduled a debate in Plenary on 8 February. This is a good example of the Assembly considering primary legislative proposals well before a Bill has been published. As an administration, we will feed views back to Westminster. I am keen to hear views from Assembly Members.

# The Ryder Cup

**Q8 Brian Gibbons:** What steps will Jenny Randerson be taking to ensure economic benefits for localities outside Gwent if Wales is awarded the next Ryder Cup? (OAQ9021)

**Jenny Randerson:** The Ryder Cup is played every two years between the United States and Europe, and the location alternates between European and American venues. The next Ryder Cup will be played at the Belfry later this year, and in 2005 the host country is Ireland.

The potential economic and other benefits to Wales of hosting the Ryder Cup tournament are significant. That is why the Assembly is committed to supporting the bid for the Ryder Cup 2009.

If Wales is successful, the Assembly, in conjunction with the Wales Tourist Board, Welsh Development Agency, Sports Council for Wales and the local authorities, who have also pledged their support, will work hard to ensure that as much of Wales as possible benefits from the event.

We await the Professional Golfers' Association's decision on which country will host the cup in 2009 with considerable interest.

# **Promoting Equality of Opportunity**

**Q9 Helen Mary Jones:** How will Jenny Randerson promote equality of opportunity within sports in Wales? (OAQ9083)

**Jenny Randerson:** I am absolutely committed to that. The Sports Council for Wales's plans for encouraging equal opportunities in sport are set out in its published strategy, 'Young People First: a Strategy for Welsh Sport'. They include identifying positive ways of promoting social inclusion, raising the profile of women in sport and providing opportunities for the disabled.

In particular, the Sports Council has established a social inclusion in sport forum with access to up to £8 million of lottery funding over the next five years. The aim is to support new approaches to tackling long-standing problems at the local level that prevent identified groups from participating in sports programmes.

**Jenny Randerson:** Cyhoeddais yn y ddadl ar 'Diwylliant Cytûn' yn y Cyfarfod Llawn fy mod yn bwriadu rhoi blaenoriaeth i Cymru'n Creu. Byddaf yn cadeirio'r fforwm, ac yn dymuno i'r aelodau nodi materion y gallant gydweithio arnynt er mwyn cyflawni amcanion pendant er lles ymarferwyr a chynulleidfaoedd, ac er mwyn gwneud cyfraniad gwirioneddol i'r strategaeth datblygu economaidd genedlaethol.

I will chair the forum, and will want its members to identify issues on which they can work together to achieve concrete objectives for the good of practitioners and audiences, and to make a real contribution to the national economic development strategy.

## Hosting the National Eisteddfod

**Jenny Randerson:** The staging of the National Eisteddfod in Denbigh this summer will undoubtedly put the town firmly in the public eye, and raise the profile and awareness of the area. The Eisteddfod is visited annually by over 160,000 people. The Eisteddfod can bring great economic benefits to the area in which it is held. It is estimated that the Eisteddfod generated £6 million for the local economy in Llanelli last year.

**Jenny Randerson:** The FA Cup is the most televised single event in the world and provides enormous opportunities to raise the international profile of Wales, and to bring us economic, tourism and sporting benefits.

The Welsh Development Agency and the Wales Tourist Board will work closely together, and with Cardiff City and County Council, Cardiff Chamber of Commerce and the Assembly, to exploit the opportunities that this event will bring.

It is important that all organisations involved in this event adopt a Team Wales approach, with a clear strategy, to maximise the benefits to local regions and the country as a whole.

## Setting up a Film Fund for Wales

**Q20 Kirsty Williams:** What progress has been made in setting up a film fund for Wales? (OAQ9097)

**Jenny Randerson:** We committed ourselves in the partnership agreement to investigating the possibility of establishing a Welsh film fund, to foster and promote cinematic excellence through the medium of Welsh and English. I met Sgrîn and Finance Wales plc on 22 January, and both organisations assured me that they are continuing to explore the proposal, with a view to harnessing Objective 1 moneys to establish the fund.

#### **Access to Sporting Facilities**

**Jenny Randerson:** The Sports Council for Wales works closely with all local authorities to ensure that the needs of any area are not overlooked.

New policy directions issued to lottery distributors require them to achieve a fair geographical spread in allocating funds.

The Sports Council has established a social inclusion in sport forum with access to up to £8 million of lottery funding over the next five years. The aim is to support new approaches to tackling long-standing problems at the local level that prevent identified groups from participating in sports programmes.

The council will offer support to potential applicants in those identified areas, assisting them in putting together appropriate lottery applications.

#### The Wales Millennium Centre

**Jenny Randerson:** The redesign and specification work that is intended to develop the plans for the centre up to the Royal Institute of British Architects' stage D is continuing. The outcome of that exercise is expected in April.

## The Communities First Programme

**Q24 William Graham:** Will Jenny Randerson make a statement on the initiatives made to encourage individuals or groups of people to incorporate artistic expression into the Communities First programme? (OAQ9078)

**Jenny Randerson:** An extensive and inclusive consultation exercise is underway in relation to the proposals for implementing Communities First, enabling all sectors of society to contribute views and ideas. Arts and cultural bodies such as the Arts Council of Wales, the Community Development Foundation, the Arts Factory, Voluntary Arts Wales and many others have been contributing to the process.

It has been acknowledged that arts and cultural development are relevant activities across and along the continuum of community development and regeneration, from simply making a community a more enjoyable place in which to live, to a community's self-identity, but also in raising self-awareness and self-esteem for the marginalised and excluded. The Communities First programme will provide scope for these activities.

**Jenny Randerson:** I have taken part in discussions with the First Minister and Minister for Finance, Local Government and Communities, and am pleased to welcome and congratulate the Millennium Stadium plc on its success in attracting the FA Cup Final to Cardiff.

**Jenny Randerson:** The Arts Council of Wales has informed the company that it is free to submit a further application for funding, which will be considered by the council on its merits.

# Impact of BNFL Sellafield Discharges on Shellfish

**Q7 Alun Pugh:** Has the Minister for Rural Affairs made an assessment of the impact of British Nuclear Fuels Limited Sellafield discharges on shellfish along the north Wales coast? (OAQ9123) *Transferred for written answer by the Minister for Heath and Social Services*.

The Minister for Health and Social Services (Jane Hutt): The responsibility for monitoring the impacts of discharges from Sellafield on shellfish in north Wales rests with the Food Standards Agency. Results from these monitoring programmes, which are published annually by the FSA and Scottish Environment Protection Agency in 'Radioactivity in Food and the Environment', show that all samples taken are within internationally-accepted limits.

Question 8 was answered in Plenary.

# The Closed Season for Canal Fishing

**Q9 Lynne Neagle:** Will Carwyn Jones give an update on the closed season for canal fishing? (OAQ9107)

**Carwyn Jones:** The Countryside Council for Wales remains opposed to the Environment Agency Wales's proposal to lift the closed season on Welsh canals. My officials met the council and the agency at the end of last week. In the light of these discussions, I hope to be able to resolve the issue in time for the coming fishing season.

# The Impact of the Rural White Paper on Wales

**Q10 Karen Sinclair:** Will Carwyn Jones give a brief statement on how the rural White Paper will impact on Wales? (OAQ9067) *Withdrawn*.

# **Swift Payment of Farm Subsidies**

Q11 David Davies: What is Carwyn Jones doing to ensure swift payment of farm subsidies? (OAQ9072)

**Carwyn Jones:** We have made significant improvements in this area, including meeting scheme targets last year.

Under the JIGSAW programme, the establishment of multi-skilled teams, new information technology and the reduction in red tape should ensure more efficient payment of farming subsidies.

On 4 October last year, I launched, 'Translating the Voice of Farming in Wales into Action', which spells out an action plan for improvements in services to farmers. A copy of the action plan was circulated to Assembly Members in November.

## **Rural Businesses**

Q12 Kirsty Williams: What plans does Carwyn Jones have to assist the development of rural businesses? (OAQ9100)

**Q18 Kirsty Williams:** What consideration has Carwyn Jones given to possible means of supporting rural businesses? (OAQ9099)

**Carwyn Jones:** The Assembly's plans to secure investment in rural businesses in Wales are set out in the single programming document for Objective 1 and the rural development plan. Copies of the documents are available in the Assembly Library.

The measures include the processing and marketing grant, the small food processors grant (to support projects that fall below the threshold for PMG), the farm improvement grant, the farm enterprise grant, the farm food processors grant (to assist the development of small-scale added value processing on-farm), and Farming Connect. The latter will provide access to co-ordinated training, information and advisory services, and a technology transfer mechanism in Wales geared to providing practical information to farmers at a local level, linked to demonstration farms and groups. It will also provide free, one-to-one business advice, including a farm business review that will look at all aspects of the farm business and help farmers decide how to take their business forward. Every aspect of the scheme will be subject to quality controls, and organisations or individuals that fail to reach and maintain these standards will not be allowed to participate.

Officials are currently developing the exact mechanisms for delivery of these measures, working with the wider industry, including the farming unions and the Young Farmers' Clubs of Wales, and it is anticipated that they will be implemented during the early part of this year.

**Carwyn Jones:** The policy and the principal laws on the release of all genetically modified organisms to the environment are determined at European Union level. The Assembly may make representations on the subject of genetically modified organisms to the UK Government with a view to influencing the development of the European legal framework, but it cannot enact legislation or take decisions that do not comply with Community law. The Assembly is currently operating as restrictive a policy on GMOs as possible, within the European Commission and domestic legislation.

**Jane Hutt:** The Food Standards Agency has responsibility for advising the Government and the devolved administrations on issues of public health relating to food, and we would consider carefully any measures that the agency proposes. The food safety interests of Welsh consumers are protected by the EU-wide system of food safety measures, which apply equally to Welsh and British food and to imports from the rest of the EU and beyond.

**Q24 Janet Ryder:** What action is Carwyn Jones considering taking to deal with the continuing low milk prices being paid to farmers? (OAQ9121) *Withdrawn*.

## **Invoking Article 16 of Directive 90/220/EEC**

**Q25 Peter Black:** What scope does the Assembly have to influence the UK Government to invoke article 16 of Directive 90/220/EEC in respect of Chardon LL in Wales and the rest of the UK? (OAQ9070)

**Carwyn Jones:** Article 16 of Directive 90/220/EEC may be invoked where there is a risk to human health or the environment. If the Assembly is aware of such evidence, then it would urge the UK Government to invoke the powers that it has under article 16.

**Carwyn Jones:** This subject will be put before the Agriculture and Rural Development Committee on 7 February.

# **Agri-monetary Compensation**

**Q28 Mick Bates:** When did Carwyn Jones last meet with the Minister of Agriculture, Fisheries and Food, Nick Brown, to discuss obtaining agri-monetary compensation? (OAQ9066)

**Carwyn Jones:** Agri-monetary compensation was one of several issues discussed at the meeting of UK agriculture Ministers on 22 January.

#### **Number of Jobs Lost from Agriculture**

**Q29 Glyn Davies:** How many jobs have been lost from agriculture in each of the last three years? (OAQ9127)

**Carwyn Jones:** Information on the number of jobs lost from agriculture is not centrally collected. Estimates for the past three years of the number of people working on agricultural holdings in Wales on the date of the agricultural and horticultural census are shown in the following table:

# **Reducing the Accelerating Loss of Employment on Farms**

Q30 William Graham: What measures is Carwyn Jones taking to reduce the accelerating loss of employment on farms in Wales, and its effect on those employed within the agricultural supply industries? (OAQ9110)

**Carwyn Jones:** There is no evidence to suggest that the long-term loss of employment on farms in Wales is accelerating. The status quo is not an option for the agriculture industry.

The farming futures group that I have set up has been tasked to prepare a long-term viable direction to sustain the future of farming across Wales. The group will present its report soon. In addition, the rural development plan for Wales and Objective 1 single programming document include measures to assist the industry and to support the development of the rural economy.
