## **Supporting Nurses**

**Q11 Lorraine Barrett:** Will the First Minister make a statement on Welsh Assembly Government support for nurses in Wales? OAQ(3)2417(FM)

The First Minister (Rhodri Morgan): The Welsh Assembly Government supports the nursing profession in a number of ways to ensure that it is fully engaged in the delivery of patient-centred healthcare and the development of new services, including by supporting sisters or charge nurses to lead and to manage ward-based care efficiently.

#### **Diabetes Treatment**

The First Minister: I expect treatment for diabetes to be in line with the National Institute for Health and Clinical Excellence guidelines, the diabetes national service framework, and the consensus guidelines for the management of diabetes in children and those for adults.

**The First Minister:** Health inequalities are still a significant issue in Wales, as elsewhere. Health inequalities will be tackled by reducing the social inequalities that lie behind them and through targeted initiatives such as the inequalities in health fund and the community food cooperative programme.

## **Primary Law-making Powers**

**Q14 Leanne Wood:** What recent discussions has the First Minister had regarding primary law-making powers for Wales? OAQ(3)2426(FM)

**The First Minister:** I have had various discussions with members of the UK Government on the devolution of powers to the Assembly under Part 4 of the Government of Wales Act 2006.

### **Flood Defences**

Q15 William Graham: Will the First Minister make a statement on flood defences in Wales?

## OAQ(3)2418(FM)

**The First Minister:** The Assembly Government provides the majority of flood risk management funding. Since 1999, funding has trebled to more than £41 million. The Environment Agency estimates that 95 per cent of its 1,800 km of defences perform as designed. The agency, together with local authorities, is preparing strategic plans to determine sustainable long-term flood management policies.
