4. Legislation

Paper on The National Assembly for Wales (Legislative Competence) (Housing) Order 2008 (previously entitled The National Assembly for Wales (Legislative Competence) (No.5) Order 2008) - BC(3)13-08(p4)

4.1 The Business Committee noted the paper on the revised Housing LCO, "'The National Assembly for Wales (Legislative Competence) (Housing) Order 2008'" (previously entitled "'The National Assembly for Wales (Legislative Competence) (No.5) Order 2008'"). At its meeting on 8th April, the Business Committee agreed as a general principle that further committee scrutiny was not necessary in cases

where the version of the LCO presented to Parliament was different to that introduced in the Assembly as plenary consideration of the final draft provided the appropriate vehicle for any concerns to be expressed. The Business Committee therefore agreed that the revised LCO should not be referred back to the Proposed Affordable Housing LCO Committee for further consideration. The Committee also reiterated its view that the Presiding Officer should determine whether or not an LCO had undergone significant changes.
