4. Legislation

Letter from Legislation Committee 2: Election of Temporary Chair- BC(3)17-09(p4)

- 4.1 The Business Committee considered a letter from Jeff Cuthbert in relation to temporary chairs of Legislation Committees. It was noted that he had been elected as temporary Chair of Legislation Committee 2 in the absence of Val Lloyd. The decision to elect Jeff Cuthbert was not in line with the Conventions agreed by Business Committee on the operation of Legislation Committees.
- 4.2 The Business Committee noted that the rationale for departing from this Convention was that the Committee would be finalising its report, and that it would be preferable for the temporary Chair to have a thorough understanding of the issues. The Business Committee agreed that, under these exceptional circumstances, it was understandable for the Committee to have departed from the Convention. However, the Committee agreed that it would not wish this to become normal practice, in particular for Stage 2 consideration of Measures.
- 4.3 It was agreed that the Presiding Officer should write to the Legislation Committee Chairs to convey the Business Committee's view.
