4.1 The Committee agreed the proposed amendments to Standing Orders in relation to the organisation of Plenary meetings.

4.2 The Committee considered a paper on options for establishing permanent committees to scrutinise proposed Legislative Competence Orders and Assembly Measures. The Committee agreed to return to the issues following further consultation with groups.

It was agreed that the Presiding Officer should write to Alun Davies to convey the Committee's view.
