4.1 The Business Committee agreed the request by the Committee on Standards to hold formal meetings after Plenary on Tuesday 15 July to consider the initial responses to its Measure Consultation to establish a statutory role of Commissioner for Standards; and on Tuesday 24 June to deal with other business.

# Revised request for the Rural Development Sub- Committee's proposed visit to Pembrokeshire and Ceredigion - BC(3)19-08(p6)

# Request from the Petitions Committee to hold an additional formal committee meeting at the Royal Welsh Show - BC(3)19-08(p7)

4.3 The Business Committee agreed the request by the Petitions Committee to hold a formal meeting on the afternoon of Wednesday 23 July 2008, as part of the Royal Welsh Show, at Builth Wells. The Business Committee noted that this meeting was to be held in recess and that the Presiding Officer had been consulted, in accordance with SO 10.41.

## 5. Legislation

# Covering paper and Illustrative Timetable for the Learning and Skills (Wales) Measure - BC(3)19-08(p8) & Supporting Paper - BC(3)19-08(p9)

- 5.1 The Business Committee agreed a proposed timetable for the proposed Learning and Skills (Wales) Measure. It was agreed that a Stage 1 Committee would be established to consider the general principles of the Measure, and that the Committee should report by 7 November 2008. To meet this deadline, it was agreed that the Committee would be established in time to have its first meeting before the summer recess.
- 5.2 To assist the work of the Stage 1 Committee and potential witnesses and consultees, the Government was asked to ensure that responses to its pre-legislative consultation exercise were made publicly available.
- 5.3 Kirsty Williams referred to the proceedings of the Learner Travel Measure Stage 2 Committee. She said that issues had arisen as a consequence of not having a Stage 1 Committee. The Business Committee noted that its decision not to refer the proposed Learner Travel Measure to a Stage 1 Committee was based on a desire not to duplicate the pre-legislative scrutiny undertaken by the Enterprise and Learning Committee. In light of experience, the Business Committee agreed that as a general principle, legislative scrutiny should be undertaken by Legislation Committees, rather than Scrutiny Committees. The Business Committee agreed that this should not prevent Scrutiny Committees from considering draft legislative proposals and that, where appropriate, this work should feed into the work of the Stage 1 Legislative Committee.
