- [2] **Huw Lewis:** The purpose of the meeting is to consider and formally agree our draft report. - [3] The draft report before you includes a number of minor drafting amendments relating to referencing and technical corrections, as discussed at the last meeting, but none of them alters the substance of the report. At the last meeting, I understand that the committee was content with the report as drafted, and did not recommend any changes to the substance of the report. I should note that officials will make any last-minute technical amendments to referencing, spellings, missing words or typographical errors after this meeting and before publication, if you feel that it is required. Once the report has been approved, the clerks will arrange for it to be published and laid bilingually before the Assembly as soon as practicable after the meeting.

- [4] It just remains for me to ask you to confirm whether you are content with the content of the report, and whether you wish to make any comments.
- [5] **Janet Ryder:** I am very happy with the report. I think that it is very good, and we should compliment the committee clerk and everyone else who has helped to draft it. People are already talking about this legislative competence Order, which I have never heard people do before, and I really look forward to getting the power and to seeing Measures passed, because that is when the meat can be put on the bones and we can see this being put into operation.
- [6] **Sandy Mewies:** I am in complete agreement with that. It is the only LCO that anyone has ever asked me about, and the public has really come on board.
- [7] **Huw Lewis:** Thank you, Sandy and Janet. I extend my thanks to you—and to Peter and Mark, in their absence. It has been a pleasure working with you all. I think that every Member of this committee has been conscientious, diligent and has really strived to understand what the LCO is about. We have had the best possible examination of the subject before us, and it is a job well done. I also thank the clerks and the team for the real hard work that was done behind the scenes.
