Item 1: Introduction, Apologies, Substitutions, Quorum and Declarations of Interest

1.1 The Chair welcomed Committee Members and Members of the public.

1.2 No apologies were received.

1.3 The Chair introduced Steve George as the new Committee Clerk in succession to Chris Reading.

1.4 The Chair sought the Committee's approval to undertake a fact-finding visit to Denmark, to gain a wider perspective of SEN delivery outside of the UK. He suggested that the visit might need to occur in the New Year. The Committee resolved to undertake the visit at an appropriate time.

1.5 The Committee resolved to use its optional meeting on 8 December to discuss emerging issues and early recommendations on the SEN review.

1.6 On the recommendation of the Chair of Legislation Committee, the Chair suggested that the Education and Lifelong Learning Committee kept the operation of the Education (induction Arrangements for School Teachers) (Wales) Regulations under review for six months.

1.7 Jeff Cuthbert declared an interest in accordance with standing order 4.6 (for item 4); he was a governor of Trinity Fields Special School and Resource Centre, Ystrad Mynach.

4.2 Amendment 1

"that the Education and Lifelong Learning Committee recommends to the Minister for Education and

Lifelong Learning:

- the amendment of the draft 'National Council for Education and Training for Wales (Transfer of Functions to the National Assembly for Wales and Abolition) Order 2005' so that responsibility for proposing the re-organisation of 6th forms, currently held by the National Council for Education and Training for Wales, is transferred to County and County Borough Councils in Wales; and
- 2. that the transfer of this function to the National Assembly should be deleted from the Order."
