Item 1: Introduction, Apologies, Substitutions, Quorum and Declarations of Interest

1.1 The Chair welcomed everyone to the meeting. Apologies had been received from Huw Jones and Andrew White of the Welsh Language Board.

Item 2: Minutes of the previous meeting, matters arising and report from the Chair

3.1 The Chair welcomed Jane Hutt AM, Minister for Assembly Business, Equalities and Children, Dr John Marek AM, Chair of House Committee; Paul Silk, Clerk to the Assembly; and Denise Rogers of Members' Research and Committee Service, to the meeting.

3.2 The Minister briefly explained the background to the Disability Equality Scheme, which was required by the Disability Discrimination Act 1995, as amended by the Disability Discrimination Act 2005.

3.3 Dr John Marek advised that the Assembly Parliamentary Service's draft Disability Equality Scheme would be considered by the House Committee in November and that issues raised during today's discussion would be taken into account when finalising the Scheme.

Action point

- The Minister, in conjunction with the Disability Rights Commission, agreed to provide a list of all conditions coming under the definition of disability, as set out in the Disability Discrimination Act.
- The Chair of House Committee agreed to e-mail all Members and their support staff advising them of the current Display Screen Equipment (DSE) and workstation assessment process, which included annual reviews for all users.
- The Chair of House Committee agreed to provide a note setting out Assembly Members' responsibilities under the Disability Discrimination Act to include information on funding within the Assembly Parliamentary Service's Budget for adaptations for Members' constituency offices to ensure disabled access.
- The Chair of House Committee agreed to provide figures on expenditure on training and development for Assembly Parliamentary Service staff.
