Explanatory Memorandum

THE GENETICALLY MODIFIED ORGANISMS (TRACEABILITY AND LABELLING) (WALES) REGULATIONS 2005

Summary

These Regulations make provision for the administration and enforcement of Regulation (EC) No 1830/2003 concerning the traceability and labelling of genetically modified organisms (GMOs) and the traceability of food and feed products produced from GMOs. The Regulations allow inspectors authorised by the National Assembly for Wales to enter premises to carry out tests, take samples and/or require the provision of information. Where an inspector is satisfied that a product consisting of or containing GMOs or food or feed produced from GMOs has not been labelled in accordance with Regulation (EC) 1830/2003, the inspector is empowered to serve a notice withdrawing or prohibiting the movement of the product until labelling is corrected. The Regulation also provides for criminal offences and penalties relating to breach of requirements of Regulation (EC) 1830/2003 and for obstruction of inspectors. Specific defences to the offences are also set out in the Regulations.

- 1. This Memorandum is submitted to the Assembly's Environment, planning and Countryside Committee in relation to the Genetically Modified Organisms (Traceability and Labelling) (Wales) Regulations 2005, in accordance with Standing Order 24.6.
- 2. A copy of the Instrument is submitted with this Memorandum

Enabling Powers

3. The powers enabling this Instrument to be made are contained in section 2(2) of the European Communities Act 1972. The National Assembly for Wales has been designated, under section 2 (2) of the 1972 Act, to make Regulations. for matters relating to the placing on the market, deliberate release and transboundary movement of GMOs, by virtue of the European Communities (Designation) (No. 4) Order 2003 (S.I. 2003/2901).

Effect

- 4. The Regulations implement in Wales Regulation (EC) No 1830/2003 of the European Parliament and of the Council concerning the traceability and labelling of genetically modified organisms (GMOs) and the traceability of food and feed products produced from GMOs. The objective of Regulation 1830/2003 is to create a harmonised EU framework for the traceability of products consisting of or containing GMOs and for the traceability of food and feed produced from GMOs at all stages of the production and distribution chain in order to facilitate effective labelling. Effective labelling will facilitate better consumer choice and risk management in relation to these products.
- 5. Regulation 1830/2003 is binding in its entirety and has been directly applicable in all Member States since 18 April 2004. Each UK competent authority is required to enforce and administer the requirements of the Council Regulation.
- 6. The Regulations will establish offences and penalties, and will empower inspectors to take enforcement action. Local Authority enforcement bodies, which already have responsibility for enforcement of the current Genetically Modified labelling requirements, will be responsible for ensuring compliance with the Regulations.
- 7. These Regulations are directly related to the Genetically Modified Food (Wales) Regulations 2004 and the Genetically Modified Feed (Wales) Regulations 2004, which implement Regulation (EC) No 1829/2003 of the European Parliament and of the Council on genetically modified food and feed, on which the Food Standards Agency (Wales) leads.

Target Implementation

- 8. It is intended that this Instrument should come into force on 15 July 2005. Similar legislation was made in England on 8 October 2004 and in Scotland on 15 November 2004. It is anticipated that similar legislation will be made in Northern Ireland on 30 June 2005. The implementation of this Instrument has been delayed in Wales for several reasons. The initial Instrument produced by Defra, and upon which this Instrument is based, was reported for defective drafting by the Joint Committee on Statutory Instruments (JCSI). There was a subsequent delay whilst that Instrument was re-drafted before Directorate of Legal Services could produce a similar Welsh Instrument. In addition, development work on GM coexistence proposals and the need to concentrate resources on taking forward the Assembly's restrictive GM policy at the European level have led to the delay in bringing forward these Regulations in Wales.
- 9. Non-implementation of these Regulations would leave the Assembly and the UK in breach of its Community obligations and would leave a gap in the enforcement of these provisions. Consumers in Wales would be disadvantaged in comparison to their counterparts in the remainder of the UK and the Assembly would be open to substantial criticism. European Regulations are directly applicable to all Member States, and the Assembly is required to implement them as soon as possible.

- 10. There are no additional financial implications for the Assembly from the making of these Regulations.
- 11. Labelling provisions will impose some direct costs, although many businesses will already have systems in place for record keeping and providing information to the final consumer.
- 12. Costs to businesses will involve:
 - The direct cost of maintaining additional information regarding the use of GM material in food ingredients, passing this information along the supply chain, and providing information on GM content through labelling; and
 - The potential indirect cost for food manufacturers arising from voluntary sourcing of alternative supplies of non-GM derived ingredients in order to avoid the need to label products.
 - 1. Main costs of enforcing the new Regulations have been identified as:
 - The cost of monitoring the accuracy of traceability and labelling;
 - Any potential testing products for GM content; and
 - The cost of imposing penalties for non-compliance.
 - 1. Since 1999, regulations have been in force requiring the labelling of GM food ingredients. The new food Regulations extend the range of food ingredients to be labelled. Local Authorities are responsible for monitoring and enforcing compliance with food labelling requirements and they will pick up responsibility for labelling under the new feed labelling requirements.
- 2. Although there were no responses from local authorities in Wales to the joint Food Standards Agency (Wales) and National Assembly for Wales public consultation exercise, one county council in England, which is specifically setting up facilities for testing, has estimated an annual running cost of £50k. However, Local Authorities Co-ordinators for Regulatory Services (LACORS UK) has indicated that this example is one extreme of the spectrum and they are not expecting other authorities to act in this way. It is not anticipated that additional costs will be incurred by local authorities. However, local authorities are being encouraged to collate information in relation to expenditure on enforcement of these Regulations, as enforcement activity will be considered as part of the European Commission's review of the Regulations.

Regulatory Appraisal

3. A Regulatory Appraisal has been prepared in relation to this Instrument and is attached. The Regulatory Appraisal jointly covers the Traceability and Labelling Regulations and the Food and Feed Regulations (i.e. the Genetically Modified Animal Feed (Wales) Regulations 2004 and the Genetically Modified Food (Wales) Regulations 2004). This approach has been taken because these Regulations are closely related and the level of crossover between them is such that a joint Regulatory Appraisal increases the transparency.

Consultation

With Stakeholders

- 4. A joint Welsh Assembly Government and Food Standards Agency Wales consultation was undertaken between 29 April 2004 and 28 June 2004. The joint consultation encompassed the Genetically Modified Food (Wales) Regulations 2004, the Genetically Modified Animal Feed (Wales) Regulations 2004, the Genetically Modified Organisms (Traceability and Labelling) (Wales) Regulations 2005 and the Genetically Modified Organisms (Deliberate Release) (Amendment) (Wales) Regulations 2005. A full list of consultees is attached at Annex A.
- 5. One substantive response was received in relation to the Traceability and Labelling Regulations. The response asked for clarification of the role of the enforcement bodies and costs to business. These issues were addressed in the final Regulatory Appraisal. Fifty-five responses in total were received to parallel consultations in the other UK administrations, of which 21 were comments on the Regulatory Appraisal. Interested parties were asked whether they agreed with the analysis of costs and benefits presented in the Regulatory Appraisal and whether there were any significant areas of benefits and/or costs not covered by the Regulatory Appraisal. Responses from interested parties have been incorporated into the final Regulatory Appraisal.
- 6. Following stakeholder comments, the Regulatory Appraisal was simplified to make it more understandable, a large amount of complex information was removed and more basic text introduced. In addition, an introductory summary was included. Respondents were unable to provide input in relation to direct and indirect costs incurred and have stated that this will be monitored over the forthcoming year. There were no changes in policy that required changes to be made to the draft Regulations.

With Subject Committee

7. The Regulations were notified to the Environment, Planning and Countryside Committee in May 2004, when the consultation papers issued, and on 6 October 2004, via the list of forthcoming legislation (EPC(2)-09-04 (P.4) Annex 1 Item No. 26). A request to scrutinise the regulations was made at the Committee's meeting on 13 April 2005 and consequently the Regulations have been tabled for EPC Committee scrutiny on 22 June 2005.

Recommended Procedure

8. Subject to the views of the Business Committee I recommend that the legislation Regulations proceed to Plenary under the Standard procedure to give Members the opportunity to debate the issue.

Compliance

9. I confirm that the proposed legislation will (as far as is applicable):

- have due regard to the principal of equality of opportunity for all people (Government of Wales Act 1998, section 120);
- be compatible with the Assembly's scheme for sustainable development (section 121);
- be compatible with Community law (section 106);
- be compatible with the Assembly's human rights obligations (section 107); and
- be compatible with any international obligation binding the UK Government and the Assembly (section 108).
