- Raise awareness amongst communities who may bring back food items from their trips abroad. Bilingual leaflets and posters have been produced. A branded mobile unit has been touring the country visiting cultural, religious and community events to promote the campaign.

The EPC inquiry report into bovine TB was published in August 2004. Based on its finding the Committee recommended that the Assembly could put in place a number of measures to contribute to the containment and reduction of bovine TB through its existing powers. In response to recommendation 4 of the Inquiry report, the Assembly established a Wales TB Action Group in November 2004 in order to considers the other recommendations of the Inquiry in detail. The Action Group, which

Co-existence: The Assembly Government has been working in co-operation with the other UK administrations to develop suitably robust GB-wide co-existence measures to protect conventional and organic produce from GM crop cross-contamination. However, if an agreement cannot be achieved on GB-wide measures, Wales will draft its own legislation. In September

2004, the Assembly held a workshop in conjunction with similar initiatives in England, Scotland and Northern Ireland, to discuss the technical issues underlying co-existence measures. The workshop was attended by experts from various farmers' union groups, NGO groups and university faculties and discussed issues of agronomic measures, a GM crop register, adventitious presence thresholds in organic produce, and voluntary GM-free zones. The outcomes of the workshop will be used in the production of a forthcoming public consultation paper.

The EPC Minister has written to the Secretary of State at Defra urging her to consider introducing new primary legislation to underpin a robust coexistence and liability regime for the UK

Legislation: Domestic legislation to enforce the EU Transboundary Movement, Traceability and Labelling and consequential amendments to the Deliberate Release Directive is due to be considered in plenary on 14th June with a view to coming into force on 30th June 2005.
