Item 1: Introduction, Apologies, Substitutions, Quorum and Declarations of Interest

- 1.1 The Chair welcomed the Committee, officials and members of the public to the meeting.
- 1.2 Apologies were received from Jocelyn Davies
- 1.3 Mick Bates declared an interest in respect of item 6 as a recipient of payment for a vodaphone mast on his land.

Item 2: Minutes of the last meetings

Papers: EPC (2) 05-06(mins)

2.1 The Committee ratified the minutes of the 23 March meeting.

Item 3: Minister's oral update

- 3.1 The Minister informed the Committee of:
 - the Review of Tir Gofal payments and that he had resolved to accept the recommendations of the working group;
 - that since legislation allowing the lifting of the beef export ban would not now be introduced in Europe until 2 May, he was disposed to partially disapply the executive procedure and table a Plenary debate on the regulations;
 - a new task and finish stakeholder group which would consider long-term options for supporting sustainable farming and the countryside to 2020. The group will report by 2007.
 - an Assembly Commission report published today which shows that there was no significant transfer of radioactivity from the Irish Sea to North Wales;
 - the intention to bring forward legislation relating to revised rates of BSE and scrapie compensation. The legislation would be debated by Plenary on 23 May with a view to its coming into force on 25 May.

Action points

The Committee agreed to scrutinise the legislation relating to revised rates of BSE and scrapie compensation at its 11 May meeting.

The Minister agreed to provide in his next written report to the Committee details of the potential impact of avian influenza on racing pigeons, particularly that of legislation relating to the vaccination of birds.

Item 4: EU Waste Strategy Paper: EPC (2) 06-06(p1)

4.1 The Minister introduced his paper and Members questioned him on the implications for Wales of the EU Waste Strategy.

Action point

The Minister agreed to provide a note to the Committee on the definitions of when certain waste flows cease to be waste, including the current position regarding the recycling of tyres through pyrolysis.

Item 5: Subordinate Legislation

The Tir Gofal (Wales)(Amendment) Regulations 2006

Paper: EPC (2) 06-06(p2)

- 5.1 The Committee sought clarification on the following:
 - the one-off accommodation cost of £600,000 associated with the Tir Gofal merger; and
 - the degree to which the merger would result in a loss of agricultural expertise and affect the freeflow of information between staff in the Countryside Council for Wales and those who have transferred to the Welsh Assembly Government to administer Tir Gofal.
- 5.2 Following discussion, the Committee recommended approval of the Regulations without amendment. Its report would be laid before the Assembly shortly.

Item 6: Planning aspects of electronic communications apparatus Paper: EPC(2)-06-06(p3)

- 6.1 The Minister introduced his paper which outlined the current land use planning system policy, legislation and guidance, as it related to the development of mobile telecommunications.
- 6.2 Members' considered the merit of undertaking future work on planning aspects of electronic communications apparatus.

Action point

The Committee agreed to invite the Welsh Local Government Association and the Mobile Operators Association to a future meeting to discuss planning aspects of electronic communications apparatus, in particular compliance with the Code of Best Practice on Mobile Phone Network Development and other relevant guidance.

Item 7: Scrutiny of the Minister on cross-cutting issues within the Environment, Planning and Countryside portfolio Paper: EPC(2) 06-06(p4), EPC(2) 06-06(p5), EPC(2) 06-06(p7) and EPC(2) 06-06(p8)

- 7.1 The Chair welcomed Amelia John of the Disability Rights Commission, Chris Myant of the Commission for Racial Equality and Prys Davies of the Welsh Language Board to the meeting.
- 7.2 Each representative gave a brief introduction outlining key issues contained in their respective paper followed by Members' questions.
- 7.3 Following this, Members questioned the Minister on progress made to date in promoting and supporting cross-cutting issues within his portfolio.
