Ireland is not eligible for the Cohesion Fund from 2004, but the Commission believes it still needs funding under the PEACE programme. To address this, the Commission proposes increasing the ceiling in the 'structural funds' heading of the Financial Perspectives (for which Ireland will remain eligible) and decreasing the amount available in the 'cohesion fund' heading. This should allow Ireland potential access to more funding opportunities.

In May 2004, the UK and Irish Prime Ministers wrote to the President of the European Commission requesting an extension to the International Fund for Ireland and a continuation of the PEACE programme for two years (2005-06). Romano Prodi responded that the Commission was also keen to continue these programmes (see document above).

The Commission believes that on the basis of the observations made in this report, post-2004 funding should continue to be made available.
