1.5 The Chair informed the Committee that he had presented a paper at the 10<sup>th</sup> Doha Forum on Democracy, Development and Free Trade. He also informed Members that he would be speaking at the Wilton Park Anglo-German Forum in July, Wilton Park being the Foreign and Commonwealth Office study centre.
