To Glyn Davies:

In my Oral Question session of 4th April, I undertook to provide you with facts and figures in relation to the cut in prescription charges.

Currently exempt prescriptions account for some 88% of the total prescriptions dispensed [93% if pre-payment certificates are included]. Some 50% of the population is exempt from charges, on grounds of age, medical condition or income.

Revenue from prescription charges covers less than 5% of the total cost of prescribed drugs. As a point of comparison, the increase in the drugs bill overall this year is twice as great as that.

For 2006-07 lost income from the cuts in prescription charges is estimated to be £16.1 million.

Over time we expect to see improvements in the health of people who no longer have to pick and choose their medication according to what they can afford to have dispensed.

To Brynle Williams:

During First Minister's Questions on Tuesday 4 April I said that I would make enquiries regarding Conwy Borough Council's introduction of a council tax rebate for householders who improved their energy efficiency.

I am pleased to see that Conwy County Council are working to promote energy efficiency in the County Borough and that they have been successful in securing funding from British Gas through their Energy Efficiency Commitment (EEC) Programme. I understand that the Council Tax rebate is only available to households who take up discounted cavity wall insulation from a British Gas EEC scheme and as such the scheme seems to be aimed predominantly at those who are 'able to pay'.

The Assembly Government's priority, however, is to assist those who are in fuel poverty. Households falling into this category are often some of the most vulnerable members of our communities. These households are able to access energy efficiency measures for free through Assembly Government programmes such as the Home Energy Efficiency Scheme or, in fact, any energy supplier's EEC scheme. Council tax rebates are not relevant to these schemes as qualifying applicants will not have had to pay or contribute towards the costs of the measures.

Nonetheless any initiative that stimulates demand and encourages the take-up of energy efficiency measures is to be welcomed.
