## Item 1: Apologies and Substitutions and Declarations of Interest

# Item 2: Review of Cancer Services – oral evidence HSS(2)-14-06(p1a), HSS(2)-14-06(p1b), HSS(2)-14-06(p1c), HSS(2)-14-06(p1d) and HSS (2)-14-06 (p4)

- 2.1 The Committee took evidence for the witnesses about the application of information and communication technology and the commissioning of cancer services. They also discussed the Minister's paper on horizon scanning new drugs and treatment for cancer patients.
- 2.2 In discussing paper 4 Members also raised the announcement by the National Institute for Health

and Clinical Excellence that it was rejecting appeals fro stakeholders on its draft guidance on the use of drugs to treat Alzheimer's disease.

#### **Action**

Committee to give further consideration in its deliberations to the issue of whether palliative care should be included in CaNISC.

The Minister agreed to provide an update in his report in December on guidance on treating people with Alzheimer's disease that NICE is due to publish in late November.

# Item 3: Equal Treatment: Closing the Gap. Report of Disability Rights Commission (DRC) HSS(2)-14-06(p2)

3.1 The Committee discussed the report of the formal investigation into physical health inequalities experienced by people with learning difficulties and / or mental health problems. The representatives of the DRC responded to questions from Committee Members.

#### **Action**

The DRC will provide the information on research carried out on UK basis on services and health checks given to people entering and being discharged from prison.

Committee to receive a paper from the Minister outlining the Government's action plan in response to the recommendations made in the report and the Committee to discuss the issues again with the DRC in the spring of 2007.

# Item 4: Secondary legislation: The Healthy Start Scheme (Description of Healthy Start Food) (Wales) Regulations 2006 HSS(2)-14-06(p3)

4.1 Members scrutinised the secondary legislation. Several points of clarification had been raised in advance to which the Minister responded at the meeting.
