Item 4: Secondary Legislation: The Commissioner for Older People in Wales Regulations 2007 and The Commissioner for Older people in Wales (Appointment) Regulations 2007 HSS(2)-17-06(p3)

4.1 No amendments had been proposed but Jenny Randerson had notified a point of clarification on Part VI of the Commissioner for Older People in Wales Regulations 2007, relating to paragraph 16 (1) and (2). She asked whether it is envisaged that there would be an annual report to the Assembly as well as the First Minister.

The Deputy Minister accepted that there was an inconsistency in the drafting of paragraphs 16 (1) and (2) and agreed that sub -paragraph (2) would be amended to refer to the Assembly not the First Minister.

The Committee took the view that the same wording should apply to regulations relating to the Children's Commissioner.
