PURPOSE

1. This paper provides some background information for the Committee on handling of the consideration of the consultation documents as set out in the agenda:

(i) agree the basis for the Committee's consideration of the documents (paragraph 2);

(ii) consider the proposed arrangements for consultation, in conjunction with regional committees, on the programme documents (paragraphs 3 and 4 and Annex1);

(iii) note the dates when other committees will be considering the documents (Annex 1);

(iv) note the dates when the Committee can further consider the documents and draw up its advice to the Assembly Secretary (Annex 1);

(v) consider what expertise or further information the committee needs to access to assist it to undertake the tasks outlined below. (paragraph 5).

BACKGROUND

2. At its last meeting the Committee discussed how it wished to take forward consideration of the consultation documents. I suggest the Committee undertakes the following tasks between now and October 19th when the National Economic Development Strategy and Single Programme Documents must be presented to the full Assembly:

(i) agree the overall strategic objectives;

(ii) scrutinize the measures proposed in the documents and be satisfied they are realistic and will be effective;

- (iii) prioritise and agree appropriate targets;
- (iv) develop a spending profile for the funding period;
- (v) ensure effective integration of cross-cutting issues;

(vi) consider the options for implementation and make recommendations.

Consultation

3. The Committee agreed that as the Task Force partners should be left to consult with their sectors, but that there was a need for the Committee to consider views on the programmes as a whole, regional views, and the views of those who had experience of implementing and evaluating such programmes.

4. The Committee Secretariat has been working to ensure that consideration of these documents by the various committees (both subject and regional) is structured and coherent. The draft timetable is at Annex 1. The Committee's views on this would be welcomed.

5. The Committee needs to consider which local/regional organisations it wishes to invite to attend the regional meetings. The public will also be invited to attend and contribute.
