Cyflwyniad, Ymddiheuriadau, a Dirprwyon Introduction, Apologies, and Substitutions

[1] **Jeff Cuthbert:** I welcome everyone to the meeting. We have received apologies for absence from Val Lloyd, Paul Davies, Sandy Mewies and Gareth Jones. Ann Jones is substituting for Val Lloyd. In the event of a fire alarm sounding, Members should leave the room by the marked emergency exits and follow the instructions given by the ushers and staff. No test has been forecast for the duration of our meeting, so if the alarm should sound, it will be real. Gorchymyn Cynulliad Cenedlaethol Cymru (Cymhwysedd Deddfwriaethol) (Llywodraeth Leol) 2009 Proposed National Assembly for Wales (Legislative Competence) (Local Government) Order 2009

[2] **Jeff Cuthbert:** I confirm, for the record, that the next piece of work to be undertaken by this committee is the scrutiny of the proposed National Assembly for Wales (Legislative Competence) (Local Government) Order 2009. In relation to our previous work on the proposed Children and Families (Wales) Measure, I clarify that, having completed its report on Stage 1, the committee will return to Stage 2 proceedings—the detailed consideration of the proposed Measure—in the autumn term. Further details will be available on the

committee's web page and via the business notice.

- [3] The purpose of this meeting is to formally agree the committee's approach to the scrutiny of the proposed National Assembly for Wales (Legislative Competence) (Local Government) Order 2009. The proposed Order was laid by Dr Brian Gibbons, the Minister for Social Justice and Local Government, on 13 July 2009. The role of this committee is to consider and report on the proposed Order. We must do so by 4 December 2009, in line with the deadline set by the Business Committee.
- [4] We have had some informal discussions on our approach to scrutiny and, on that basis, I propose that the framework for the committee's work should be to consider whether the general principles of the proposed Order—that is, legislative competence, as specified in matters 12.8 to 12.17—should be conferred on the Assembly; whether the proposed Order provides an appropriate framework for the delivery of the policy proposals relating to community councils and councillor recruitment, retention and allowances; and, in particular, whether the terms of the proposed Order are too broadly or too narrowly defined. Are Members content with this approach? I see that you are.
- [5] Are Members also content to issue a general call for evidence via the Welsh media and the Assembly's website, to invite written submissions from organisations and individuals, and to invite key stakeholders to give oral evidence during the autumn term? I see that you are.
- [6] Members have been advised that the next meeting of the committee will take place on Thursday, 24 September 2009, during which it is hoped that we will take evidence from the Member in charge, Dr Brian Gibbons, the Minister for Social Justice and Local Government.
- [7] Are there any further points? I see that there are none. I therefore declare the meeting closed.
