Dechreuodd y cyfarfod am 9.33 a.m. The meeting began at 9.33 a.m.

Cyflwyniad, Ymddiheuriadau a Dirprwyon Introduction, Apologies and Substitutions

David Lloyd: Croeso ichi gyd i [1] gyfarfod diweddaraf Pwyllgor Deddfwriaeth Rhif 3 a thrafodaeth ynglŷn â'r Mesur Arfaethedig ynghylch Llywodraeth Leol (Cymru). Yr wyf yn croesawu fy nghyd-Aelodau a'r sawl sydd yn cyrraedd yr oriel gyhoeddus. Fel sylwadau agoriadol, os bydd larwm tân, dylai Aelodau a swyddogion adael yr ystafell drwy'r allanfeyddd tân penodol a dilyn cyfarwyddiadau'r twysywyr a'r staff. Nid ydym yn disgwyl prawf y bore yma. Dylai pawb ddiffodd eu ffonau symudol, eu galwyr a'u 'mwyar duon' gan eu bod yn amharu ar yr offer darlledu. Bydd pawb yn ymwybodol bellach bod Cynulliad Cenedlaethol Cymru yn gweithredu'n ddwyieithog. Mae clustffonau ar gael ar gyfer clywed cyfieithiad ar y pryd, a gellid hefyd addasu'r sain arnynt ar gyfer pobl sy'n drwm eu clyw. David Lloyd: I welcome you all to the latest meeting of Legislation Committee No. 3 and our discussion regarding the Proposed Local Government (Wales) Measure. I welcome Members and those arriving in the public gallery. By way of opening remarks, if the fire alarm sounds, Members and officials should leave the room through the marked fire exits and follow instructions from the ushers and staff. Mesur Arfaethedig ynghylch Llywodraeth Leol (Cymru)—Cyfnod 2: Ystyried Gwelliannau Proposed Local Government (Wales) Measure—Stage 2: Consideration of Amendments

David Lloyd: Bwriad y cyfarfod [2] gwelliannau hwn vw ystyried y gyflwynwyd mewn perthynas â'r Mesur Arfaethedig ynghylch Llywodraeth Leol (Cymru). Cwblhawyd ystyriaeth Cyfnod 1 o egwyddorion cyffredinol y Mesur arfaethedig y tymor diwethaf, a symudwn yn awr i Gyfnod 2, sef ystyriaeth o'r gwelliannau sydd wedi eu cyflwyno. Er mwyn cymryd rhan yn v cyfarfod, dylai Aelodau fod â'r dogfennau a ganlyn o'u blaenau: copi o'r Mesur arfaethedig, rhestr o'r gwelliannau wedi'u didoli a'r ddogfen sy'n grwpio'r gwelliannau a drafodir heddiw. Y rhestr o welliannau wedi'u didoli yw'r rhestr o'r holl welliannau a gyflwynwyd sydd wedi'u didoli yn ôl trefn yr adrannau yn y Mesur arfaethedig. Ystyrir David Lloyd: The purpose of this meeting is to consider the amendments tabled in relation to the Proposed Local Government (Wales) Measure. Stage 1 consideration of the general principles of the proposed Measure was completed last term, and we now move on to Stage 2 to consider the amendments tabled. To participate in the meeting, Members should have the following documents before them: a copy of the proposed Measure, the marshalled list of amendments and the groupings of the amendments for debate. The marshalled list of amendments is the list of all amendments tabled that have been marshalled into the order in which the sections appear in the proposed Measure. Schedules will be considered with the

relevant sections that introduce them. You will see from the groupings list that amendments have been grouped to facilitate debate but the order in which they are called and moved for a decision is dictated by the marshalled list.

There will be one debate on each group of amendments. I will call the proposer of the first amendment in the group, who should speak to and move their first amendment and speak to the other amendments in that group. I will then call other speakers including any other proposers of amendments in that group but they should not move their amendments at that stage. Members who do not have an amendment in the group but who wish to speak should indicate their wish to speak in the usual way. I will call the Minister to speak on each group. To conclude each debate, I will call the proposer of the first amendment in the group to wind up. I do not intend to allow interventions other than in exceptional circumstances—in exceptional circumstances—to ensure that the debate is properly focused but all Members will have an opportunity to speak in the debates on each group.

Following the debate on a group, I will clarify whether the Member who moved the first amendment still wishes to press it to a decision. If not, he or she may seek the agreement of the committee to withdraw it. If it is not withdrawn, I will put the question on the first amendment in the group that the amendment be agreed to. It is my intention that all votes should be recorded so that the names of those voting for, against or abstaining will be recorded in the minutes. I will call the proposers of other amendments in each group to move their amendments at the appropriate time and in accordance with the marshalled list. If you do not wish to move your amendment, you should say so clearly when the amendment is called. For the record, only committee members can move amendments. I will move amendments for the Minister.

Members will be aware that the only way to debate a section of the proposed Measure is to have tabled an amendment to it. David Lloyd: The first group of amendments relates to the production of annual reports by members of local authorities. The only amendment in this group is amendment 57, which is on page 1 of the marshalled list. I invite Veronica German to move and speak to amendment 57.

- [7] **Veronica German:** I move amendment 57 in my name.
- [8] The reason for this amendment is our belief that any good councillor will inform their constituents about what they are doing on their behalf, and therefore there is no need to legislate on this matter. If councillors do not inform their constituents about what they are doing, then it is up to those constituents to decide whether their representatives have done a good job or not when they return, at the end of the term, to the ballot box. There is a danger that these reports could simply be a tally of the number of meetings attended, rather than an outline of the work that a councillor has done in their area, given that no political content is to be allowed. Therefore, that could give a skewed vision of who is a good councillor and who is not a good councillor.

- We also believe that we should legislate only when legislation is necessary. We believe that this is an unnecessary piece of legislation and will do nothing to inform constituents of the good and bad councillors who may represent them.

David Lloyd: A oes unrhyw Aelod David Lloyd: Does any other Member wish to say something on this amendment? I see that no-one does. I call the Minister to speak to this amendment.

- Carl Sargeant: I thank the committee for the opportunity to discuss these amendments. Our proposal is to introduce annual reports to help local people to understand the duties that councillors perform locally; they are not to be political or any form of party propaganda. They would purely be based on fact and activity within councils, and they would be for all councillors.
- [12] The annual reports will be subject to the guidance of the Assembly Government, which we will be providing, and to the code of practice of the local authority. As Veronica said, some good councillors already produce summary reports, but we are trying to create a level playing field for the public at large to understand what councils and councillors do. On that point, Chair, I ask the committee to reject the amendment.

- David Lloyd: Galwaf ar Veronica David Lloyd: I invite Veronica German to German i gynnig gwelliant 60 ac i siarad move and speak to amendment 60. amdano.
- **Veronica German:** I move amendment 60 in my name. [17]

- We believe that for a Minister to give guidance about the times at which meetings of a local authority are held is far too prescriptive. We understand the sentiment behind it, and we agree that the time of meetings can sometimes put people off from wanting to be councillors in the first place, and even when they are on the council, it can prevent them from being able to carry out their duties. However, we believe that the consideration of the best time to hold meetings should be done by those attending council meetings. It is important that a local authority ensures that the times of meetings are accessible to its members, but that should be done in its own way. It just seems a bit like taking a sledgehammer to crack a nut to allow the Minister to tell local authorities at what time they should hold their meetings. I know that the Minister has said in the past that he does not intend to say that there will be a meeting at 9 a.m. every Tuesday, for example. As it is now, you might not take it upon yourself to do that as Minister. However, where it is written in legislation, it may be that a Minister at a later time might do that. Therefore, we believe that it could be over-prescriptive. We understand the sentiment behind it and there is definitely a need for all local authorities to consider the issue of meeting times, but we do not think that it is necessary for the Minister to have this amount of involvement. It should just be on the face of the proposed Measure.
- David Lloyd: A oes Aelod arall David Lloyd: Does any other Member wish [19] eisiau siarad? Mae distawrwydd llethol, to speak? There is complete silence. I call on Galwaf ar y Gweinidog i siarad am y the Minister to speak to this amendment. gwelliant hwn.

- Carl Sargeant: I will speak to amendments 60 and 59 together. We have had a long discussion about the profile of councillors in local authorities, and I think that it is wellrecognised that the overwhelming profile is white, male, elderly and retired. There was an agreement around how we create an environment to be able to engage people in the work of councils. It is useful to give reassurance to you, Veronica, but also to correct some of the points that you made. We will not be setting times for council meetings and saying that they should start at 9 a.m.. The guidance in the proposed Measure is for local authorities to consult with interested parties on how they can encourage a better environment and on what times are best for them. I will not, as Minister, be stipulating what times they should be, and neither will a future Minister. This is about a process to engage people better, to understand what is preventing people from becoming members of the council. Broadly, what we are trying to do, through surveys and so on, is to encourage more of a broad-brush approach to how people can engage. That is the process that we are taking. I urge the committee to resist these amendments.

David Lloyd: In accordance with the marshalled list, we move to amendment 59. Veronica, would you like amendment 59?

- [25] **Veronica German:** I do not wish to move that amendment now, as it is consequential to amendment 60.

- While we agree that the functions assigned to the head of the democratic service, as [29] currently drafted, should be provided for by local authorities, we do not believe that local authorities should be obliged to create a new position to do this, particularly at chief officer level. It should be left to individual councils to decide.

Carl Sargeant: I will speak to opposition amendments 48, 52, 49, 50, 53 and 54 initially. To clarify one of William's points, this is not proposed to be at chief officer level. I believe that the amendments will make it very unclear about the responsibility for the democratic services in a local authority. We are trying to encourage or create a very clear and intended way to ensuring that the function of the democratic services officer will provide

services as independently as possible from the executive, which is currently avoided in some councils. Giving good advice for scrutiny and support for backbenchers or opposition members is a fundamental point in good scrutiny and public services. That is the position in terms of that. I would certainly urge the committee to resist those opposition amendments.

- [32] If I may, Chair, I will move on to amendments 51 and 55 specifically. The amendments have the effect of making small changes to the list of functions in the democratic services committee set out in section 9. I believe that they are unnecessary and prove unhelpful in terms of the actual specifics, in terms of what we are tasking the officer of democratic services with doing. The understanding and purpose of scrutiny is a function for all of council, the purpose being that the initial support for scrutiny from democratic services should be independent of the executive. However, the general principle of scrutiny in education should be available to all councils, which is why we are trying to make it very clear within the sections of the proposals. Again, I urge Members to resist the amendments.
- [33] I now turn to amendment 2, as it deals with the post of head of democratic service, which I have discussed.
- [34] I must check that I am in the right place. I am sorry. There are just so many amendments in this, Chair. I am trying to keep up. [Laughter.]
- [35] Government amendment 2 is intended to reinforce the independence of the head of democratic services, as I have just alluded to. I ask the committee to support amendment 2.
- [36] The purpose of amendment 1 is to clarify the provision of section 10 and to address the recommendations made in the committee reports at Stage 1. The amendment would allow the Welsh Ministers to make regulation under the authority's standing orders. It was perceived as a broad regulation, but we were actually specific about democratic services in the standing orders. We have just narrowed that to tidy it up. I hope that Members will be able to support that amendment.
- [37] Turning to amendments 3, 4 and 5, they amend section 14 to strengthen the independence of the chair of the democratic services. Again, the effect of amendment 3 would be to introduce a requirement that, normally, the chair must not be a member of the executive. Again, we are trying to make a clear definition between the executive, backbenchers and support for the democratic service process. That is to say, in the case of a political group that has members in the authority's executive, we are making provisions. Where there are cases like Wrexham, which is cross-party, the member in charge of the committee should not be a member of the executive. We are just trying to tidy that up in terms of that process.
- [38] Amendment 4 introduces one permitted exception, which is, as I have just mentioned, that the chair of democratic services may be a member of the executive group, but not a member of the executive itself. That is for the sake of clarity.
- [39] There are still many more amendments in this group, Chair. Amendment 5 provides the necessary link for the definition of the executive group, which is quite a technical element of this part of the proposed Measure. The purpose of the amendment is to safeguard the independence of the democratic services, and, as I said, to make that separation.
- [40] In conclusion, I ask committee members to resist amendments 51 and 55, along with amendments 48, 52, 49, 50, 53 and 54. I ask the committee to support amendments 1, 2, 3, 4 and 5.
- [41] **David Lloyd:** Galwaf ar William **David Lloyd:** I call on William Graham to reply to the discussion.

- William Graham: I support amendments 1 to 5. With regard to amendments 51, 55, 53 and 54, I would like to remark that section 9, as drafted, outlines the functions of the head of democratic services, and they include a responsibility to provide support and advice to members of the executive of the authority. I do not feel that the head of democratic services should have a responsibility to do this, as local authority executives should already have a support team in place. I realise that the head of democratic services would only have to provide information to the executive in relation to the overview of scrutiny committee functions, but I feel that this is an unnecessary function and responsibility to be placed upon that person.

Section 23 makes amendments to the Local Government Act 1972, which are necessary as a consequence of the provisions in relation to family absence that we are introducing in Part 2 of the proposed Measure. As things stand, section 23 precedes the

provision that introduces family absence. It would therefore be more logical for that provision to be at a later stage in the proposed Measure, hence the amendment.

- [86] Amendment 8 removes the third of the three definitions of 'executive' that are given in section 32 of the proposed Measure. As you will be aware, Chair, section 32 provides a definition of certain terms that are used in Part 2. The third definition of 'executive', in subsection (c), refers to an executive that is prescribed in regulations made by Welsh Ministers under section 11 of the Local Government Act 2000. We believe that it is confusing and unnecessary, in applying the provision in Part 2, to include that in the interpretation section, as the reference is purely hypothetical. It refers to an executive that does not exist at present in Wales, and never has existed. Should regulations ever be made under section 11 of the Act, it will be possible to introduce those regulations when necessary, to ensure that provision relating to family absences is extended to the new form of executive arrangements. Therefore, I ask the committee to support the amendments.

- [94] Carl Sargeant: I will speak to amendment 64, which is the key amendment in the group; I believe that all of the other amendments in the long list that you provided earlier, Chair, are effectively consequential to this amendment. I am slightly surprised by this debate as the elected-mayor and council-merger option was one of the executive arrangement models that were introduced in the Local Government Act 2000. In all the years since it has been in operation, no interest in this proposed model has been expressed in Wales. The only case of this ever having been an option in England arose in Stoke-on-Trent and that experiment was ended soon afterwards with the abolition of the elected-mayor and council-merger option for England by the Local Government and Public Involvement in Health Act 2007. There were certainly no squeals of protest from Stoke to say that abolishing the option was a problem. I am surprised by the sudden emergence of interest in it.
- [95] We consulted on the proposals for this part of the proposed Measure between December 2009 and March 2010 and there was hardly any disagreement on the proposal to abolish the option. If local authorities or residents want an elected mayor—I know that that is something that William and his party have often debated—there is still an option for the elected-mayor model and a cabinet executive to be adopted. This seems to be a much more open and democratic arrangement in terms of accountability than the option of a mayor coupled with a council manager that is put forward in this proposal. I see no need to keep the option in legislation when it is unused, and when there appears to be no interest in its use; it is, therefore, effectively redundant, and that is why I urge the committee to resist all of the amendments.
- [96] **David Lloyd:** Galwaf ar William **David Lloyd:** I call on William Graham to reply to the debate.
- [97] William Graham: We continue to believe that directly elected mayors could be transformational for major towns and cities in Wales; for example, the Mayor of London was a great help in attracting the Olympic Games. Accountable to the public, elected mayors are proven to provide greater leadership and direction in local authority areas, and improved performance and delivery of local public services. The London borough of Hackney, for example, moved from being a one-star authority in 2005 to a three-star authority within three years of electing a mayor. If Mansfield, Bedford and Torbay can have directly elected mayors, so could Cardiff, Swansea and Newport. We note that a directly elected mayor and cabinet will remain an option in the proposed Measure, but we believe that flexibility is required in the system for local authorities to decide what model is best for them, should they choose to have a directly elected mayor.

Authorities Changing the Executive Arrangements and Alternative Arrangements (Wales) Regulations 2004 are revoked and that provisions in Part 3 and Part 4 of the proposed Measure will render those regulations obsolete. Those sections are repealed in their entirety in the proposed Measure. Technically, the regulations made under those sections would fall at the same time.

- [115] Amendment 11 corrects an error in section 56 of the proposed Measure, and inserts the correct title of the National Assembly for Wales.
- [116] Amendment 12 will allow Welsh Ministers, when making regulation in relation to joint overview and scrutiny committees, to include provision on the treatment of confidential and exempt information in the publication of reports of joint overview and scrutiny committees.
- [117] Amendment 13 corrects an oversight in section 62 of the proposed Measure. Section 55 allows local authorities and the executive of the local authority to make arrangements for the function of an authority or executive to be discharged by a backbench councillor. I would consider it appropriate that if backbench councillors are able to exercise their responsibilities formally on behalf on an authority, they should be accountable to the authority's scrutiny process.
- [118] Amendments 14, 15 and 16 need to be taken together. They recast section 64 of the proposed Measure to read in a more logical manner so that the section is divided into subsections and adds provisions that were unintentionally omitted. The third of these amendments will insert provision into section 64 so that section 22 of the Local Government Act 2000 is applicable in Wales and will extend the power to Welsh Ministers to make regulations about the publication of local authority executive responses to reports and recommendations of the scrutiny committee.
- [119] Amendments 17, 18 and 19 must be taken together. The effect of these amendments is to clarify the terminology in section 76 of the proposed Measure, which deals with subcommittees and the overview of scrutiny committees.
- [120] Amendment 26 inserts the word 'order', which was accidentally omitted from the last line in section 10. The sentence does not make sense currently.
- [121] Finally, in this group, amendment 29 corrects a drafting error in section 145 and clarifies that the independent remuneration panel will be able to make decisions about the payment of allowances in circumstances where a councillor has taken family absence under the provision in Part 2 of the proposed Measure. As I said, Chair, these are primarily technical amendments, and I ask the committee to support all of these amendments.

People see local authorities as public service providers. They play an important part in terms of the scrutiny. An enabling power would, in reality, mean little practical change. Local authorities are already able to make reports or recommendations to local authorities or the executive on the matters that affect the authority's area in this principle. We want scrutiny to have teeth. Making it a duty will give committees the teeth that I believe that they need. It will fulfil the Beecham proposals to make local authorities' scrutiny play a key role in public accountability of the broader public sector, which is what we believe that this provision relates to.

[139] I have noted the concerns that this will place unfair burdens and responsibilities, and we expect scrutiny committees to be sensible and proportionate in the way that they use this provision and that view will be reflected in the guidance provided. The requirement in section 80 that scrutiny committees must prepare and publish forward plans should act as a corrective if committees are scrutinising an organisation too often or not often enough. So, I urge the committee to resist these amendments.

I think that it is fundamentally antidemocratic. - [198] **David Lloyd:** Galwaf ar Veronica **David Lloyd:** I call on Veronica German to German i gynnig gwelliant 58 a siarad move amendment 58 and speak to it. amdano.
- [199] **Veronica German:** I move amendment 58 in my name.
- [200] We had a lot of discussion about this in committee. Many of us were concerned about the practicalities of prohibiting the use of the party whip. In an ideal world, we think that this would be good and sensible. However, we think that legislating on this, by placing the role of ruling on whipping on the chair, is also impractical. You could have a situation with lots of vexatious complaints coming forward and disrupting the processes that were going on, and people might use it for reasons that perhaps were not intended in your legislation as you brought it forward. So, we believe that if you are going to legislate for something, it has to be something that you can enforce. We do not believe that you can enforce this legislation and that it puts far too much of a burden on the chairs. So, with those reasons, we think that this whole section should be left out.
- [201] **David Lloyd:** A oes unrhyw Aelod arall yn dymuno siarad? **David Lloyd:** Does any other Member wish to speak?
- [202] Helen Mary Jones: I find myself slightly conflicted about this amendment, Chair. I do not think that anyone on the committee would want to be sending the message that we approved of whipping in scrutiny committees. However, on the other hand I share some of the concerns that have been raised by Veronica German with regard to the practicality of this. So, in this context, I would ask the Minister to give some further consideration to this; perhaps he could provide us with some reassurance as to how he proposes to put this into practice. If I support the amendment today, my concern would be that we could be tacitly seen to be condoning a practice of which we all disapprove. However, I share Veronica's concerns about the possibility of vexatious complaints and the possibility that this clause will drive whipping underground, making it more difficult for the public to see where that is occurring. So, in the context of the debate today, I would be interested to see what the Minister has to say. However, as we move towards Part 3, I would ask the Government to give further consideration to the implementation and the exact nature—whether this section is the right way to achieve what we all seek to achieve.
- [203] **William Graham:** We appreciate the Minister's intention to discourage hidden whipping and agree that good governance is enhanced by good scrutiny. However, we believe that the policy will be almost impossible to enforce. I strongly agree with the Welsh Local Government Association that
- [204] 'it is unlikely that robust evidence to support any allegations or suspicions of whipping would ever be available.'
- [205] I also agree with a remark made by Caerphilly County Borough Council that it is not a practical solution. While we appreciate the sentiments behind this section of the proposed Measure, we do not believe that abolition of the party whip could be enforced practically.
- [206] **Joyce Watson:** This gives some power to backbenchers, because there will be cases in which members feel strongly about something and they will not have to, or be seen to, follow a party line, but they will represent the people by expressing their individual thoughts on whatever they are discussing. The prohibition of whipped votes, in other words, banning them, strengthens the backbenchers in local government and gives them a real opportunity to speak up for their people whenever and wherever they are discussing issues that are or seem to be critical to the people whom they are representing. It will serve to reinforce the idea that individual members are individuals when they are undertaking scrutiny; they are not just party

members who are putting up their hands at the same time for the same cause on every single occasion. It is that that brings me to support it. We can always say 'Do we know or don't we?'. However, do we know now, or not? What is the difference? This is a get-out clause for the people who truly want to think for themselves and do the job that they have been elected to do, namely to serve the people.

[207] Christine Chapman: To add to what Joyce has said, the proposed Measure is about giving diversity to local government. This is an area that encourages people to come into local government, because it is about independent thinking and doing an effective job. This is part of what the proposed Measure is about.

[208] Carl Sargeant: I welcome Members' comments about their concerns and I would be happy to have further discussions with any Member regarding how, at Stage 3, we can strengthen this through guidance or through the proposed Measure. I say that also with an air of surprise at some of the comments that have been made on this. As Joyce said—probably better than I could—this is about strengthening the position of members serving on scrutiny committees so that they are not tied to any particular whipping system. The role of scrutiny committee is to hold decision-makers to account and we believe that the role of a whip is fundamentally contrary to that.

[209] I will say, once again, that I am surprised. The Health, Wellbeing and Local Government Committee raised concerns about whipping in 2009 when it examined the scrutiny of local government. Peter Black sat on that committee and was part of that formal discussion. The Assembly committee recommended that, once we had legislative competence, the Assembly Government should bring forward proposals to strengthen the current injunction against whipping in scrutiny committees. That is what we have tried to do. It was said that scrutiny members must be given the necessary support and training to help them to understand that the role means that they are freeing themselves in some way from the party bans of the old committee structure. That means that there must be freedom from the whip, as highlighted in the recommendations, and that was mentioned by Lord German in 2004, in the new political management structures. So, I am somewhat surprised by some of the comments today, as they seem to be politically out-of-kilter. I urge Members to resist this amendment.

[211] **Veronica German:** There is no doubt that we all agree with the sentiment, but we do not think that it is practical—that is the problem. Does it mean that Members of the Assembly, where there is no prohibition of the party whip, cannot sit on a scrutiny committee and give their individual opinions on things? I do not think that that is the case—I have sat on many committees where many individual opinions have been expressed, and it does not seem to have stopped people from expressing them.

[212] If there is no formal whip, there will be an informal whip in certain authorities, so what is worse? I do not see that formal whipping goes on at the moment. You can see that people may vote the same way, but not all the time. The whole point of the chair having that responsibility and the way in which this has been put forward is completely unworkable. I do not disagree with Joyce when she says that she wants to strengthen the role of backbenchers, but I am not convinced that this is the way to do it. Therefore, I stand by the amendment.

- [219] **Carl Sargeant:** I will speak to amendments 20, 21, 22, 23, 24 and 25, starting with amendments 20 and 21 which make changes to the remit given to audit committees by section 84 of the proposed Measure.
- [220] These two amendments address the concerns expressed during scrutiny stages by the Chartered Institute of Public Finance and Accountancy and the Wales Audit Office. We have had dialogue with both organisations, which believed that the provisions of the proposed Measure were drawn too narrowly. In particular, they did not capture enough of CIPFA's existing guidance on audit committees, which Welsh Ministers have long endorsed.
- [221] Amendment 20 redraws the range of functions that could be the responsibility of the audit function to include the monitoring and reporting of the risk management framework, internal control and corporate governance arrangements.
- [222] Amendment 21 removes the requirement for an audit committee to consider the financial integrity of members and officers of the authority, which was also deemed to be inappropriate and impractical for audit committees. The new sub-sections that allow flexibility for local authorities to confer the other functions of the audit committee are considered suitable. CIPFA and the Wales Audit Office were closely consulted about these amendments and what we are trying to do by way of change. It was never our intention to move away from that principle—a drafting error caused that miscommunication. We have hopefully allayed those fears.

- [223] The combined effect of amendments 22, 23 and 24 is to amend the requirements in section 86 of the proposed Measure about the chair of the audit committee, so that they recognise the circumstances where a local authority's executive contains representatives from all the political groups. Section 86 of the proposed Measure provides that the chair of the audit committee must not be a member of a political group that is represented by the authority's executive. The Assembly shares a similar principle.
- [224] Finally, in this group, I will speak to amendment 25, which relates to section 88 and widening the scope of the guidance that the Welsh Ministers could issue on audit committees. It would be able to cover the functions and membership of the audit committee and not just the exercise functions, as currently provided. Again, this is in line with advice from CIPFA and the Wales Audit Office that guidance on these additional issues could be useful to audit committees. I ask the committee to support the six amendments.

The current regulations allow for only 50 per cent of members to receive a special responsibility allowance. The relevant regulation will be revoked by the proposed Measure, and this amendment will mean that the panel will still be able to apply a limit to the proportion of council members who may receive a particular payment. The panel itself identified the omission and requested that the facility to make payments on this basis be restored to the panel. I believe that this makes sense, as it gives the panel an effective tool that will help to limit the scope for executive leaders to use the remuneration system for the potential distribution of patronage.

[269] As an additional constraint on potential abuse or extravagance, the amendment also introduces a requirement that the panel will have to seek consent from Welsh Ministers if it wishes to exceed the 50 per cent limit with regard to a particular payment. I ask the committee to support this amendment.

[270] All of the other amendments in this group are consequential to amendment 30. Amendment 31 allows the panel to take follow-up administrative action in the wake of making a determination based on the percentage of members who receive a certain type of payment. Amendment 32 will enable the panel to specify different amounts for different authorities. It is consistent with the panel's flexibility to make other determinations. Amendment 33 requires the panel to publish any determination that it makes in relation to elected members who receive an allowance in its first annual report. It must take this action for all such determinations. Amendment 34 enables the panel to vary any determination that it makes regarding the proportion of members who receive a particular payment in the supplementary report to the first annual report—action that it may take for other determinations that it makes through that process.

Amendment 36 will allow the panel to vary any determination it makes regarding the proportion of elected members who receive payments subsequent to the annual report. Amendment 37—the final amendment in this group—will enable the panel to vary any determination that it makes regarding the proportion of elected members who may receive a payment in any subsequent supplementary report. Again, this is an action that it may take for any other determinations it makes. They are very similar, yet very different to each other. I ask the committee to support amendment 30 and supporting amendments 31, 32, 33, 34, 36 and 37.

The existing provision enables the panel to issue guidance, but is silent on the varying or revoking of the guidance. Again, I urge the committee to support that amendment.
