CYFEIRIADAU POST

POSTAL ADDRESSES

Ers ad-drefnu llywodraeth leol, mae'r Post Brenhinol wedi parhau i ddefnyddio 'Gwynedd' yn hytrach nag 'Ynys Môn' ar gyfeiriadau post. Mae'r mater hwn yn destun pryder i'r Cyngor Sir a chyflwynwyd sylwadau arno eisoes i'r Post Brenhinol.

Since local government re-organisation, Royal Mail have retained the use of 'Gwynedd' as opposed to 'Ynys Môn/Isle of Anglesey' on postal addresses. This issue is of concern to the County Council and has been the subject of representations to Royal Mail.

Cyflwynwyd yr adroddiad sydd ynghlwm i Bwyllgor Polisi ac Adnoddau'r Cyngor ar 23 Tachwedd, 1999 ac mae'n crynhoi'r materion o bwys yn yr achos hwn. Mae Mr Ieuan Wyn Jones AS/AC a Phwyllgor Ymgynghorol y Post a Thelathrebu (Arfon, Dwyfor, Môn) yn cefnogi safiad y Cyngor yn hyn o beth.

The attached report submitted to the Council's Policy and Resources Committee on the 23rd November, 1999 summarises the issues of relevance in this matter. The Council's position is supported by both Mr. Ieuan Wyn Jones MP/AM and the Post and Telecommunications Advisory Committee (Arfon, Dwyfor, Môn).

Penderfynodd y Pwyllgor dderbyn yr argymhelliad yn yr adroddiad a gofynnwyd i mi ddwyn sylw Cymdeithas Llywodraeth Leol Cymru a Phwyllgor Rhanbathol Cynulliad Cenedlaethol Cymru at bryderon y Cyngor.

The Committee resolved to accept the recommendation in the report and that I be requested to highlight the Council's concerns to both the WLGA and the Regional Committee of the National Assembly for Wales.
