2.1 The minutes of the previous meeting were agreed.

## **Item 3: Draft Accommodation Report on Accommodation Arrangements for the National Assembly for Wales**

3.1 The Committee resolved to exclude the public from this part of the meeting in accordance with Standing Order 8.21(vi):

*(vi) the committee is deliberating on the conclusions or recommendations of a report it proposes to publish; or is preparing itself to take evidence from any person.*

3.2 The committee further resolved that the Officials from the Northern Ireland Audit Office were not deemed to be members of the public for the purposes of that resolution.

3.3 The Committee considered the draft report and agreed publication. Members particularly noted their concerns already expressed in the Report regarding continuing lack of signed contract with the architects.

### **Other Business**

4.1 The Chair noted that, at the next meeting on 29th March 2001, evidence would be taken on the *National Assembly Resource Accounts 1999-2000* and *the General Report of the Auditor General for Wales: Financial Audit of 1999-2000 Accounts*.

4.1 The Chair raised the possibility of holding an evidence session with NHS Trusts on the Clinical Negligence Report at the meeting scheduled for 3rd May.

4.2. The committee raised a query regarding who would take responsibility for liability for civil actions after the disbandment of the Health Authorities. Members queried whether the evidence session with the NHS trusts could be widened to include the disbandment of the Health Authorities. Sir John Bourn advised that advantages lay in concentrating on the report. He offered to provide a note to the Committee on the disbandment of the Health Authorities and the impact upon the National Health Trusts, but advised that it would be difficult to provide an analysis at this stage which the committee could use for an effective evidence session.

4.3 The Committee agreed it did not wish to meet on 3 May if the UK general elections were being held on that date. An alternative date for that meeting would need to be sought. The Chair requested that the Clerk consider this in conjunction with the Business Committee.
