# PET(3)-11-09 Paper 3: 7 July 2009

### **New Petitions**

This paper provides brief background information on the petitions to be given initial consideration by the Committee on 7 July 2009.

### (i) P-03-222 National Osteoporosis Society

### **Petition wording**

The National Osteoporosis Society calls upon the National Assembly for Wales to urge the Welsh government to fully implement the Falls and Fractures Standard in the National Service Framework for Older People, ensuring that patients with and at risk of fragility fractures are identified, assessed and treated by Fracture Liaison Services (FLS) in all of the new Local Health Boards. We would like a FLS to be linked to every hospital that receives fragility fractures, and ask that the Welsh government insists upon universal provision of FLS's across the NHS in Wales

# **Background**

This petition was raised by the National Osteoporosis Society, and it collected 18 signatures. The petitioner has provided a supporting statement, and this is attached as part of PET (3)-11-09 Paper 3A.

### (ii) P-03-223 Section 6, Welsh Language Act

### **Petition wording**

We call upon the National Assembly for Wales to investigate the possibility of amending and improving Section 6 of the Welsh language Act to bring Members of Parliament under the provisions of the Welsh Language Act

### **Background**

This petition was raised by Councillor O Arfon Jones, and it collected 23 signatures. The petitioner has provided supporting information, and this is attached as part of PET(3)-11-09 Paper 3A.

### (iii) P-03-225 Gorseinon College

### **Petition wording**

We call upon the National Assembly for Wales to urge the Welsh government to provide extra funding to Gorseinon College to keep courses and classes open and running.

# (iv) P-03-226 Sands - the stillbirth and neo-natal death charity

# **Petition wording**

We call upon the National Assembly for Wales to urge the Welsh Assembly Government to:

- 1. Take note of the new Saving Babies' Lives Report 2009, published by Sands in support of its Why 17? Campaign
- 2. Develop a strategy for reducing levels of stillbirths and neonatal deaths in Wales
- 3. Fund further research to improve understanding of why stillbirths and neonatal deaths happen
- 4. Develop gold standard antenatal care provision in all NHS Trusts in Wales
- 5. Work with Sands to improve public awareness of these issues

## P-03-231 Proximity of wind turbines to residential dwellings

### **Petition wording**

We ask the Assembly to review the current position on the proximity of wind turbines to homes, which is now 500m. (see para. 3.4, Annex D of TAN8).

We would ask that the minimum distance be 2KMs as in Scotland.

Besides problems of noise, there have been many accidents and the closeness to homes affects the visual amenity of residents.

### P-03-232 Ffynnone and Cilgwyn Woods

# **Petition wording**

Cyngor Cymuned Manordeifi Community Council calls upon the National Assembly for Wales to urge the Welsh Government to commission an independent inquiry into the funding of Calon yn Tyfu / Growing Hearts Ltd. by Forestry Commission Wales for the purchase of the Ffynnone and Cilgwyn woodland in North Pembrokeshire under the publicly funded Cydcoed Scheme.
