### Updates on previous petitions

#### (i) P-03-088 Rural Bus Services, Taliesin

We understand that the Assembly has found in favour of the Rhondda Cynon-Taf Education Authority's action in changing the name of Ysgol Gyfun Rhydyfelen, and of the methods used to bring about this change.

We find this to be a matter of disappointment and consternation. The decision has far-reaching obligations with respect to the powers and rights of school governing bodies in general. It also, of course, ratifies the Authority's ill founded and unwarranted decision to eliminate a school name which has had such prominence in the history of Welsh education, and in doing so, to flout the opinion consistently expressed by the school's governors, parents, pupils, through the School council, and staff.

We understand that Lord Gwilym Prys Davies has already contacted the members of the Petitions Committee. We wish to support his request for a speedy amendment of the relevant legislation, whereby the right to change the name of a school is returned to governors

#### **(xxii) P-03-235 Abandon the Badger Cull (RSPCA petition)**

##### **Petition wording**

Please sign the petition today and voice your protest against the Welsh Assembly Government's decision to cull badgers in Wales part of a strategy to tackle bovine tuberculosis (bTB) in Cattle.

The RSPCA is shocked by the decision to cull badgers but welcomes the plans to increase cattle testing and biosecurity.

The Independent Scientific Group (ISG) supervised a badger culling trial in England, which took 10 years, cost £34 million, and the lives of nearly 11000 badgers. The research found that culling badgers alters the social behaviour of remaining badgers which, in turn, increases the risk of the disease spreading to other badgers and to cattle. Only by wiping out badgers over very extensive areas might this increased risk of disease be avoided. The ISG concluded that culling badgers on such a scale was not a feasible control option, because of logistical, economic, legal, environmental and welfare concerns.
