Item 1: Introduction, Apologies and Substitutions

1.2 The Chair reported that he had received a letter from the Petitions Committee referring a petition calling for plastic bags to be banned in Wales to the Sustainability Committee. The Committee agreed to ask Members' Research Service to produce a scoping paper on the petition.

Item 2: Inquiry into carbon reduction in Wales: evidence session on carbon reduction by transport

2.1 The Chair welcomed leuan Wyn Jones AM, Deputy First Minister and Minister for Economy and Transport, and his officials, Robin Shaw and Martin Stevenson, to the meeting. The Chair invited the Minister to introduce his paper. Members questioned the witnesses..

2.2 The Minister agreed to provide information on the weighting given to carbon impacts within the Welsh Transport Appraisal Guidance and a comparison of estimates of carbon savings from the proposed actions contained within the Minister's paper against estimates of the projected rises in traffic growth.

2.3 The Minister also agreed to provide written responses to questions on eco-driving, railway infrastructure, demand-responsive transport solutions, and the effects on tourism.
