Proposed Terms of Reference for the Committee's Inquiry into Carbon Reduction in Wales

Purpose

1. This paper puts forward suggested terms of reference for the Committee's first scrutiny inquiry into carbon reduction in Wales. 2. Members are invited to agree the terms of reference, the proposed project plan at Annex A and the proposed list of witnesses for the first topic of the inquiry at Annex B.

Background

3. At its meeting on 12 July, the Committee agreed to investigate carbon reduction in Wales as its first inquiry. 4. A scoping paper, outlining the background to and some of the issues for carbon reduction in Wales is paper 2 for this meeting.

Proposed terms of reference

5. To scrutinise the Welsh Assembly Government on its progress in contributing to the UK's carbon reduction targets and its proposals for meeting the 3% per year carbon reduction target for Wales contained in the One Wales document. The inquiry will focus on the following topic areas:

Residential carbon reduction
Carbon reduction by transport
Carbon reduction by industry and public bodies
Carbon reduction from electricity generation (including renewable energy)
Rural land use management and carbon reduction
The role of the planning system in carbon reduction

It is proposed that a written consultation is carried out at the start of the inquiry into each topic area.

Annex A

Proposed detailed project plan for the Sustainability Committee's Inquiry into Carbon Reduction in Wales

It is proposed that the Committee conducts the carbon reduction inquiry as a series of topic inquiries, each following on from the other with the relevant Minister being scrutinised at the end of each topic. The results of each topic inquiry would then be pulled together to from the Committee's final report and recommendations.

Proposed timescale for the autumn term 2007

Thursday 20 September Agree terms of reference and discuss scoping paper Thursday 4 October Strategic view of carbon reduction in the UK and Wales - The Environment Agency, The Carbon Trust, The Energy Saving Trust

1st topic - Residential carbon reduction

4th topic - Carbon reduction by the energy production industry (to include renewable energy production)

To follow on from the conclusion of the 3rd topic.

5th topic - Rural land use management and carbon reduction

To follow on from the conclusion of the 4th topic (may only need 1 or 2 meetings)

6th topic - Carbon reduction through the planning system

To follow on from the conclusion of the 5th topic (may only need 1 or 2 meetings) It is envisaged that the next 2 or 3 meetings can be used to review the evidence and identify and hear evidence from any person or organisation who has been 'missed' from the topic areas. It is hoped that the final report and recommendations will be agree by the Committee by the start of the summer term.
