Item 1: Introduction, Apologies and Substitutions

Item 2: Inquiry into carbon reduction in Wales: evidence session on industry and public bodies Papers: SC(3)-03-08 (p.1) and (p.2)

- 2.1 The Chair welcomed Ruth Wood from the Tyndall Centre and Lorraine Frater from the Centre for Business Relationships, Accountability, Sustainability and Society, at Cardiff University, to the meeting and invited them to introduce their written submissions. Members questioned the witnesses.
- 2.2 Ruth Wood agreed to provide information on the impact of aviation on CO₂ emissions.
