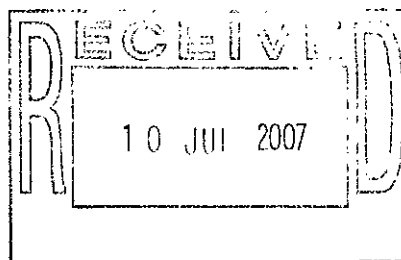

We would like to take the opportunity of using the petitions system under the new powers of the Welsh Assembly Government.

The petition wants a stronger Coal M TAN that provides:-

- A strict presumption against opencast coal mining in our communities for any new applications or extensions from now onwards.
- A 500 metre minimum separation distance that is 'absolute' should any future opencast go ahead. The 500m should only be flexible for increase and have no caveats to reduce it.
- The 500m should include all homes, even 1-9 dwellings (that are at present not protected at all by the 350m existing distance) These rural hamlets and the citizens in isolated dwellings have, at present, unequal status and protection.
- The public consultations that took place after the Draft coal M TAN was released showed public in favour of 500m which would, in effect, have a presumption against if implemented.
- Because the people of Wales are on and near the coal, further opencast mining should be discouraged as there are environmental, health and social studies that advocate its unsuitability as sustainable, acceptable or healthy development for the future.

### **Coal M TAN**

#### **Purpose**

The Committee is asked to consider the attached petition, submitted by Mrs Gaynor M Ball.

#### **Background**

This petition requests a stronger Coal M TAN that provides:

- A strict presumption against opencast coal mining in our communities for any new applications or extensions from now onwards.
- A 500metre minimum separation distance that is 'absolute' should any future opencast go ahead. The 500m should only be flexible for increase and have no caveats to reduce it.
- The 500m should include all homes, even 1-9 dwellings (that are at present not protected at all by the 350m existing distance). These rural hamlets and the citizens in isolated dwellings have, at present, unequal status and protection.
- The public consultations that took place after the draft Coal M TAN was released showed public in favour of 500m which would, in effect, have a presumption against if implemented.
- Because the people of Wales are on and near the coal, further opencast mining should be discouraged as there are environmental, health and social studies that advocate its unsuitability as sustainable, acceptable or healthy development for the future.

The petition has received 77 signatures of support.

authority, but, in this instance, the permission was actually granted by the Assembly, as constituted under the Government of Wales Act 1998. Any powers that the Secretary of State had, given the workings of the Government of Wales Act 2006, are now to be exercised by Welsh Ministers. That is where the sensitivity arises, because they may be considering their own actions.

[160] **Val Lloyd:** What are the committee's wishes on this?

[161] **Michael German:** It seems that the only thing that you can do here is to refer it to Welsh Ministers to consider whether they will pursue the action that the petitioners want.

[162] **Andrew R.T. Davies:** If they were so minded.

[163] **Val Lloyd:** It seems to me that it had a pretty thorough hearing, but we can certainly put it to the Minister.

[164] **Andrew R.T. Davies:** Likewise, it would be for the Minister to come back and say that it has had a good hearing, and that x, y and z has been said.

[165] **Val Lloyd:** Of course it would; I am not denying that.

[166] **Andrew R.T. Davies:** The petitioners are simply asking us, as a committee, whether we would be good enough to pass the petition on to the Ministers, for them to say whether they would be prepared to look into it, using their discretionary powers.

[167] **Bethan Jenkins:** If they have new evidence that they would like to release—

[168] **Val Lloyd:** They have not said that though, have they?

[169] **Ms Jackson:** I am not aware of any new evidence.

[170] **Andrew R.T. Davies:** They are requesting the use of discretionary powers. If the Minister turns around and says, 'Well, no, I am not minded to do it', that is fair enough.

[171] **Val Lloyd:** It is actually saying to use 'any discretionary powers'; it does not say that they necessarily have or do not have them. It just says 'any discretionary powers'. That is why I asked you.

[172] **Michael German:** What we are looking for is an opportunity for the Government to consider this issue and, if it feels that it cannot proceed, for it to identify the grounds and reasons why it cannot proceed and to tell us in some detail why that is the case.

[173] **Val Lloyd:** We will take it forward on that basis.

[174] **Andrew R.T. Davies:** It is giving the petitioners an outcome, is it not?

[175] **Val Lloyd:** Yes; at least we are following it through. Thank you. I am glad that we reached a consensus.

[176] The petition on the coal MTAN is slightly different, is it not? I believe that, for the first TAN, there was no guidance, but the second one came up with a 350m buffer zone, but only for safety reasons. That is only from memory.

[177] **Michael German:** I think that this petition is much easier to deal with: this is one that should go to the committee. The committee needs to look at whether the coal TAN, as it

currently exists, is satisfactory in this respect. As we do with other things, we could ask the committee if it would mind looking at the coal TAN, to see whether it feels that it should be amended. You can obviously send it to the Minister, but it requires more detailed investigation. I think that that is something that we could do.

[178] **Val Lloyd:** I am not averse to that, but I am saying that the TAN has been amended—you can now have a 350m buffer zone.

[179] **Michael German:** The petitioners are requesting something more stringent than that. I support that, but—

[180] **Andrew R.T. Davies:** The coal TAN needs to be looked at by the committee.

[181] **Michael German:** It is not us who have the job of scrutinising the TAN.

[182] **Val Lloyd:** No, I am not claiming any expertise in that area.

[183] **Michael German:** That is why all you would be doing is passing it to the committee to ask it to consider the revision.

[184] **Val Lloyd:** Bethan, do you have a comment on that one?

[185] **Bethan Jenkins:** Yes. I do not see why we cannot pass it on to the committee and for the committee to then pass it back to us, for us to consider.

[186] **Val Lloyd:** Do we really need that?

[187] **Mr George:** Sorry, I am just a little unclear. Are we talking about—

[188] **Michael German:** We are passing it to the relevant Assembly committee.

[189] **Mr George:** I see; you are passing it to the relevant Assembly committee. I misunderstood.

[190] **Michael German:** We will ask the committee if it would consider the petition and let us know what its views are on revising the coal TAN.

[191] **Andrew R.T. Davies:** It will be the same as the way we dealt with the petition on Carno railway station.

[192] **Bethan Jenkins:** Because there is a vital—[*Inaudible*]

[193] **Val Lloyd:** We are talking at once and I think that we may be confusing the clerk. I include myself in that. That shows that we are interested and engaged in the process, but perhaps we should try to speak one at a time.

[194] The Petitions Committee is now asked to look at the banning of plastic bags. If you remember, this was the petition that won the BBC competition.
